


Chalkmead, Deans Road, Merstham, Redhill, RH1 3HE





About Chalkmead

Chalkmead is a purpose-built residential care home, constructed around 1980. It provides accommodation and personal care for up to 50 people who may be living with dementia or have needs related to being an older person. Admissions during the pandemic have reduced and as of 9 September 2021, 27 people called Chalkmead their home

Chalkmead is a two-storey building divided into five separate living areas with each having its own lounge and dining room. There is a main kitchen and staff facilities and the home is set around a courtyard, which has a sensory garden and seating for residents. Chalkmead has established very strong links with local schools and the

local church. Services are regularly held in the home and volunteers from the congregation visit to spend time with the residents. A local volunteer also brings along their pet dog so people can enjoy its company. Set in the village of Merstham, the home is close to local services, local shops, a park and train station.

Chalkmead was inspected by the Care Quality Commission in May 2018. It was rated 'good'. The CQC report for Chalkmead can be viewed here

Background

Surrey County Council initially built and ran Chalkmead before its management was transferred to Anchor Hanover Trust in the late 1990s on a long-term contract.

On 31 March 2019, the contract with Anchor Hanover Trust ended and the council took back the responsibility for operating the care home.

Since taking back the care home, the council has undertaken internal reviews of the building structure and commissioned independent property surveyors, Savills, to undertake a building condition survey.

About the service

The dedicated staff at Chalkmead work hard to provide a caring service for all people living in the home. Over time fewer people are choosing to move into a residential setting, preferring to remain in their own homes and local area for as long as possible. When people do need to move to a residential care setting, they often have more complex conditions and require specialist care and support. In addition, when families and potential future residents do view the home, some tell us they are looking for a service with more modern facilities.

Staff also work very hard to make Chalkmead as homely as possible, and to deliver dignified care. The layout of the home and the bedroom sizes in particular are relatively small in comparison with new build care homes. This means it is a challenge to accommodate the additional equipment, such as hoists or other mobility aids that many people with complex needs require to safely get in and out of bed or move around the building. The bedrooms lack access to any en-suite facilities meaning bathrooms and toilets are shared by both men and women living in that area of the home. Many people today prefer having their own facilities, as these afford greater privacy and dignity to the individual. Over the last two years it has also become increasingly evident that shared facilities present a challenge when managing the control of infections such as norovirus, flu and COVID-19.

About the building

In December 2020 independent property surveyors Savills were appointed to inspect Chalkmead and prepare a report on the condition of the building. The full report is available on Surrey Says, or a paper version is available upon request. (See contact details at the end of this document.)

The report's main findings were that the home is well cared for but considered to be beyond its optimal economic lifespan. The building is reaching an age where maintenance and running costs are significantly higher than the industry standard. Due to wear and tear, failure of the infrastructure and equipment could happen at any time.

Considerable investment would be needed to bring Chalkmead up to modern standards and expectations.

About the costs

The council regularly monitors expenditure to understand how much it costs to provide services. These are broken down by care home and show how much it costs the council to provide care and accommodation for one person for one week.

Costs are separated into revenue costs (the cost of providing care to residents on a day to day basis e.g. staff salary, food, heating and lighting) and capital costs (generally one-off expenditure on a building or equipment such as replacing a roof or fitting of replacement boilers).

Information provided by Savills has enabled the council to compare anticipated costs of continuing to provide services from Chalkmead as detailed below:

The anticipated weekly cost of providing care per person over the next 30 years is estimated to be:

- £867 per week continue to operate the services maintaining Chalkmead as it is now
- £1068 per week partially modernising facilities and reducing the number of bedrooms
- Where alternative placements need to be found we would seek to utilise capacity within our existing block funded and contracted care home provision or where needed approach the independent sector. These costs may vary depending on the needs of the individual and the local circumstances.

What are the options being considered?

There are three options for consideration:

Option 1: Maintain and sustain Chalkmead Care Home and continue to meet building compliance standards

This option would mean no significant changes to the building or service.

There are various issues to consider for this option, for example:

 Chalkmead would continue to find it challenging to accommodate people with complex care needs due to the constraints and limitations of the building Shared bathing and toilet facilities would continue to impact on privacy and the control of infections within the home

Option 2: Modernise and refurbish Chalkmead Care Home

This option would mean major refurbishment or reconfiguration to bring the home up to a standard that is fit for the future, with a more suitable environment, including ensuite facilities.

There are various issues to consider for this option, for example:

• This may require residents to be moved from Chalkmead for a period of time to enable works to be completed.

Option 3: Support residents to move to an alternative care home and close Chalkmead Care Home.

This option would mean the council working closely with residents and their families to find an alternative care home.

There are various issues to consider for this option, for example:

- Surrey County Council adult social teams would reassess the needs of the people living at Chalkmead and work with other providers of care to secure alternative, quality services
- Surrey County Council will support staff to be redeployed or to find alternative employment externally
