#### Introduction



Surrey County Council want to support you to benefit from all available opportunities.



We support people who have eligible care needs by promoting independence, choice and control.



We want to enable people to be as mobile and independent as possible.



We want to help people meet their goals and achieve their ambitions.



This policy shows how Surrey County Council can support people within its duties under the Care Act 2014.

### What is the policy for?



This policy shows how residents are supported to travel to an activity or occupation that meets their needs under the Care Act 2014.



In line with the community vision for Surrey in 2030 everyone will be supported to be part of their local community.



The policy tells people how decisions about travel are made by Surrey County Council.

## What Surrey County Council must do



If you have care and support needs these are assessed under the Care Act.



It is the law for the council to meet eligible needs.



Sometimes to meet your needs you may attend a day service, activity or occupation.



If you can get there by yourself or with support from family or friends, the council will not pay for you.

## What Surrey County Council must do



If you cannot get there on your own or with support the council may pay for you to get there.



You can talk about this when you are assessed or reviewed.

## Who does this apply to?



This policy is for people who have eligible needs under that Care Act 2014. They must also need support to travel to an activity to meet their needs.



If you are 18 – 25 and go to college, you need the Post 16 travel policy.



People who live in residential homes or nursing homes are not covered by this policy.



Adult Social Care do not pay if you need help to go to a health appointment.



You may be able to get your money back for health appointments though the <a href="Healthcare Travel Costs Scheme">Healthcare Travel Costs Scheme</a>. You may be able to use <a href="Non-emergency patient transport">Non-emergency patient transport</a>.

### The policy



Surrey County Council want to support people to be independent and be able to live their best lives.



If people find it difficult to travel to a service that meets their needs, the council will arrange travel support to get there.



We will only arrange or pay for transport if you cannot travel safely and independently or with support to meet the day centre /activity or occupation that meet your assessed need.



If a carer or family member needs to visit you in your home, they will have to pay for this journey.

## What are we aiming for?



Be person centred.



Promote independence.



Develop skills and the use of technology.



Promote choice and control.

## What else are we aiming for?



Support carers wellbeing.



Support people to be in their community.



Promote Surrey's values.



Support value for money and better outcomes.



Promote green ways of travelling.

#### How we will do it



The Social Worker will talk about travel needs as part of your assessment.



We will look at direct payments.



If your family member or friend helps with your care and support, they will be offered a carers assessment.



If the person has a Motability vehicle, they will be expected to use it.

#### How we will do it



If you say no to the travel support offered, we may not pay for your preferred choice.



If you are eligible for travel support a risk assessment may be completed.



We want people to be connected to their local community so you may be offered the closest service to your home.



If you want to go to a service that is further away the council may not pay for the extra travel costs.

#### How we will do it



Where people get a taxi, this will be reviewed often.



People may become more independent.



A new travel and transport service may become available.



A person may need different support to get to different activities.



Transport to each activity will be looked at one at a time.

# Young adults moving from children's services



When a person becomes an adult, they are looked after by the <u>Transition team</u>.



The transition team works with people aged 18 to 25.



The Transition team will complete an Adult Social Care assessment.



The assessment will consider people's strengths and promote independence.



If a person is 18 – 25 and has an Education Health and Care Plan (EHCP) they will be covered by a different policy: SEND Travel assistance policy for learners aged 16 – 25.

### One person taxis



Sometimes people that live together or live close by may go to the same service.



If so, the social worker may talk to people about sharing a taxi.



Some people don't like to sit in a car for a long time, others may enjoy this. We will talk to each person to see what they think.

## Charging for transport



If a person receives support from Adult Social Care, they will have a financial assessment.



Personal Independence Payment (PIP) / Disability Living Allowance (DLA) are not counted as income.

# Mobility allowance and the motability scheme



If a person has a Motability car or receives Mobility Allowance this will be part of the assessment.



If a person can drive the Motability car themselves, they will be expected to do this.



If a friend, family or support worker normally drives the car for the person they will be expected to do this.



If the Mobility allowance doesn't pay for a car, then it will not be considered.



If a Motability Car cannot be driven by anyone it will not be considered.

# More about mobility allowance and the motability scheme



No mileage or other travel costs will be paid by the council.



People cannot use a Motability car for their own benefit that is meant for another person.
