Proposal to expand the Harbour Centre (Special Educational Needs Unit) at Hythe Primary School

Consultation Meeting

The Proposal

Surrey County Council and the Governing Body of Hythe Primary School are proposing to expand the SEN Unit from 25 places to 41 places and to formally dual-designate the unit as MLD and ASD.

*Autistic Spectrum Disorder (ASD) is the term used by the Department for Education (DfE) as the school designation that meets the needs of autistic pupils and those with communication and interaction needs. Moderate Learning Difficulties (MLD) is the DfE school designation, known locally in Surrey as Learning and Additional Needs (LAN).





The current setting

The Harbour Centre (SEN unit) at Hythe Primary School has a formal designation of MLD.

Currently, the local authority has an agreement with the school for the infant year groups to be available for autistic pupils and those with communication and interaction needs.

The overall existing provision can only accommodate a maximum of 25 planned places.





Why are we consulting now?

This consultation is a proposal to secure school places for autistic pupils and those with communication and interaction needs by increasing the number of places available in Key Stage 2 (Years 3 to 6).

Overall, The Harbour Centre will expand from 25 to 41 planned places.

A feasibility study will inform the development approach required to expand the centre at Hythe Primary School to ensure long-term sustainability.



North West - Forecast of demand for special school and SEN unit places from Year R to Year 6 for pupils with an EHCP with a primary need of autism or communication and interaction needs








Demand for specialist places North East Surrey

North East - Forecast of demand for special school and SEN Unit places from Year R to Year 6 for pupils with an EHCP with a primary need of autism or communication and interaction needs








Demand for specialist places North West Surrey








Demand for specialist places North East Surrey

- To expand the SEN unit to meet the needs of 25 autistic pupils and those with communication and interaction needs.
- To maintain the offer of 16 places for pupils with moderate learning difficulties.







- A continuous educational offer from Year R to Year 6.
- An inclusive offer where pupils spend around 40% of the time (usually afternoons) in their mainstream class, accessing the mainstream curriculum, alongside their peers.

 We have offered a successful LAN/MLD provision at KS2 since 2004 and feel it is important to continue to meet these needs in our local community.



 In 2017, we extended our provision into KS1 for children who have communication and interaction needs and ASD, and want to now extend this into KS2, to allow children who benefit from mainstream inclusion to continue to progress through our school.





We have a high staff/ low pupil ratio, meaning we can offer a personalised curriculum for each child with the level of support they need. Activities and lessons are multi-sensory and differentiated, enabling all children to access the curriculum.









SEND Capital Programme

The expansion and formal change of designation at the SEN unit at Hythe Primary School is part of a suite of proposals being developed by Surrey County Council to deliver a step change in the number of places for learners who have complex SEND in local special schools and SEN units or resourced provision in mainstream schools.
