



## **Statutory Notice**

### **St Peter and St Paul Church of England (CE) Infant School**

Notice is given in accordance with section 19(1) of the Education and Inspections Act 2006, as amended by the Education Act 2011, that Surrey County Council, in co-operation with the Governing Body of St Peter and St Paul CE Infant School and the Southwark Diocesan Board of Education, intends to make a prescribed alteration to St Peter and St Paul CE Infant School from 1 September 2022.

It is proposed to expand St Peter and St Paul CE Infant School from a one form entry infant school to a one form entry primary school from September 2022. As a result, the school will be enlarged from a 90 place Infant School, offering 30 places per year from Year R to Year 2, to a 210 place Primary School, offering 30 places per year from Year R to Year 6.

This notice forms part of a linked proposal whereby the Governing Body of St Peter and St Paul CE Infant School, in co-operation with Surrey County Council and the Southwark Diocesan Board of Education, proposes to change the age range of the school from 4 to 7 years to 4 to 11 years. This linked proposal provides Surrey County Council with the opportunity to re-organise primary places in an area of Caterham by providing an all-through primary school which will benefit the local community.

The future arrangements for Admissions at the school and statutory entitlement to transport assistance will not be altered by this proposal.

Surrey County Council has complied with all applicable statutory requirements to consult in connection with this proposal. At the conclusion of the Notice period, if the proposal is approved by the Surrey Cabinet Member for Education and Learning, Surrey County Council, in co-operation with the Governing Body of St Peter and St Paul CE Infant School and the Southwark Diocesan Board of Education, will implement the proposal.
