Proposed 40mph Speed Limits
London Road (A30) and Blacknest Road (A329) Egham/Virginia Water

Surrey County Council Propose to make the Surrey County Council The London Traffic (40 m.p.h Speed Limit) (No.1) Regulations 1959 (Amendment) Order 202-, under Section 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers, the effect of which will be to impose a 40 mph speed limit on the length of roads in the Schedule to this Notice, by amending The London Traffic (40 m.p.h. Speed Limit) (No. 1) Regulations 1959. The speed limit proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.

Schedule (1) London Road (A30) Egham/Virginia Water, from a point 14m north-east of the centre line of St David's Drive to the existing 40 mph restriction 137.16m (150 yards) north-east of its junction with Christchurch Road; **(2)** London Road (A30) Virginia Water, between the existing 40 mph speed limit 123.44m (135 yards) south of its junction with Blacknest Road and a point 320.04 metres (350 yards) north-east of its junction with Shrubbs Hill Lane; **(3)** Blacknest Road (A329) Virginia Water, from the existing 40 mph speed limit 160m (175 yards) west of its junction with London Road to the Surrey County/Royal Borough of Windsor & Maidenhead boundary.
