## SURREY COUNTY COUNCIL - BOROUGH OF GUILDFORD

## PROPOSED IMPOSITION OF A BANNED LEFT-HAND TURN BY VEHICULAR TRAFFIC FROM FARNHAM ROAD (A31) INTO THE DRIVE (D4017), GUILDFORD

- 1. SURREY COUNTY COUNCIL ("THE COUNTY COUNCIL") PROPOSE TO MAKE The Surrey County Council (The Guildford Traffic Regulation Order 1965) (Amendment) (No.) Order 202- under Sections 1(1) and 2(1) to (3) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") and of all other enabling powers, the purpose and effect of which would be to prohibit the left-hand turn by vehicular traffic proceeding in a north-easterly direction in Farnham Road (A31) into The Drive (D4017), Guildford.
- 2. The prohibition referred to above would not apply to -
- (a) anything done with the permission or at the direction of a police constable in uniform; and
- (b) a vehicle being used for ambulance, fire brigade or police purposes in an emergency; and
- (c) anything done in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Police.
- 3. A copy of the proposed Traffic Regulation Order, together with a plan showing the lengths of roads to which that Traffic Regulation Order relates, a Statement of the County Council's reasons for proposing to make the Traffic Regulation Order, The Guildford Traffic Regulation Order 1965 (and the relevant amending Orders) and a Statement of the County Council's Guidelines for the Acceptance of Objections to Traffic Regulation Orders may be inspected, free of charge -
- (a) at Guildford Library, 77 North Street, Guildford, Surrey, GU1 4AL on Mondays, Wednesdays and Fridays between 9.30 a.m. and 5.30 p.m., on Tuesdays and Thursdays between 9.30 a.m. and 7 p.m. and on Saturdays between 9.30 a.m. and 5 p.m.; or
- (b) at the Main Reception, Guildford Borough Council, Millmead House, Millmead, Guildford, Surrey, GU2 4BB during office hours on Mondays to Fridays inclusive; or
- (c) by prior arrangement by telephoning or emailing the County Council's Merrow Complex situated at Merrow Lane, Merrow, Guildford, Surrey, GU4 7BQ (Telephone No. 0300 200 1003) or Email: <a href="mailto:highways@surreycc.gov.uk">highways@surreycc.gov.uk</a>) between 9 a.m. and 5 p.m. on Mondays to Thursdays inclusive and 9 a.m. and 4.30 p.m. on Fridays.
