SURREY COUNTY COUNCIL - BOROUGH OF GUILDFORD

PROPOSED REDUCTION OF THE EXISTING 40 MPH TO A 30 MPH SPEED LIMIT ON A LENGTH OF THE A31 FARNHAM ROAD AT GUILDFORD

1. SURREY COUNTY COUNCIL ("THE COUNTY COUNCIL") PROPOSE TO MAKE The Surrey County Council (The London Traffic (40 m.p.h. Speed Limit) (No. 28) Order 1965) (Part Revocation and Amendment) Order 202- under Sections 81, 82, 83 and 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") (as amended) and of all other enabling powers, the purpose and effect of which would be to revoke the existing 40 mph maximum speed limit imposed by The London Traffic (40 m.p.h. Speed Limit) (No. 28) Order 1965 (S.I. 1965/745) ("the Order of 1965") on that length of the A31 Farnham Road which extends from its junction with Scillonian Road south-westwards to the lamp column lettered and numbered N38 situated at a point approximately 50 metres south-west of the junction of the A31 Farnham Road with The Drive (D4017), a distance of approximately 520 metres -

(NOTE – The length of the A31 Farnham Road referred to above would then become subject to a 30mph maximum speed limit by virtue of the street lighting system currently provided on that length of road).

2. A copy of the proposed Speed Limit Order, together with a plan showing the length of road to which that Speed Limit Order relates, a Statement of the County Council's reasons for proposing to make the Speed Limit Order, the Order of 1965, The Surrey County Council Farnham Road (A31) and Down Lane (C147) in the Borough of Guildford (30 mph Speed Limit and 40 mph Speed Limit and Part Revocation and Amendment) Order 2021 (and the plan which accompanies that sealed Order), The Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 (S.I. 2011/935) and a Statement of the County Council's Guidelines for the Acceptance of Objections to Traffic Regulation Orders may be inspected, free of charge -

- (a) at Guildford Library, 77 North Street, Guildford, Surrey, GU1 4AL on Mondays, Wednesdays and Fridays between 9.30 a.m. and 5.30 p.m., on Tuesdays and Thursdays between 9.30 a.m. and 7 p.m. and on Saturdays between 9.30 a.m. and 5 p.m.; or
- (b) at the Main Reception, Guildford Borough Council, Millmead House, Millmead, Guildford, Surrey, GU2 4BB during office hours on Mondays to Fridays inclusive; or
- (c) by prior arrangement by telephoning or emailing the County Council's Merrow Complex situated at Merrow Lane, Merrow, Guildford, Surrey, GU4 7BQ (Telephone No. 0300 200 1003) or Email: highways@surreycc.gov.uk between 9 a.m. and 5 p.m. on Mondays to Thursdays inclusive and 9 a.m. and 4.30 p.m. on Fridays.
