Abinger Lane (C43) Sutton Lane (D281) and Evelyn Cottages (D571) Abinger (20mph and 30mph Speed Limit) Order 202-

Surrey County Council propose to make the above named Order, under Section 84 of the Road Traffic Regulation Act 1984 "the Act" (as amended) and all other enabling powers, the effect of which will be to impose a -

- (a) 20mph speed limit in the lengths of roads specified in the First Schedule to this Notice;
- (b) 30mph speed limit in the length of road specified in the Second Schedule to this Notice.

The speed limits proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.

First Schedule 20mph Speed Limit

- (a) Abinger Lane (C43) Abinger that length which extends from its junction with Hollow Lane to a point 16m north-west of the north-west boundary of Rew Cottage;
- **(b)** Sutton Lane (D281) Abinger that length which extends from its junction with Abinger Lane to a point 67m west of the entrance to Abinger Manor;
- (c) Evelyn Cottages (D571) Abinger its entire length.

Second Schedule 30mph Speed Limit

Abinger Lane (C43) Abinger – that length which extends from a point 16m north-west of the north west boundary of Rew Cottage to its junction with Raikes Lane
