The Surrey County Council
(Horsham Road (A281) and Guildford Road (A281) Alfold)
(40 MPH and 50 MPH Speed Limit) Order 202-

Surrey County Council propose to make the above-named Order under Section 84 of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers the effect of which will be to

- (a) impose a 40 miles per hour maximum speed limit in that length of road specified and described in the First Schedule to this Notice;
- (b) impose a 50 miles per hour maximum speed limit in those lengths of road specified and described in the Second Schedule to this Notice.

The speed limits proposed by the above-mentioned Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.

First Schedule

that length of Guildford Road (A281) Alfold which extends from a point 690 metres northwest of its junction with (D182) Alfold Road to a point 50 metres southeast of its junction with (D182) Alfold Road

Second Schedule

- (a) those lengths of Horsham Road (A281) and Guildford Road (A281) which extend from a point 200 metres south of the southern kerb-line of Elmbridge Road (B2130) Cranleigh south-eastwards to a point 690 metres northwest of its junction with (D182) Alfold Road
- (b) that length of Guildford Road (A281) Alfold which extends from a point 50 metres southeast of its junction with (D182) Alfold Road to a point 82 metres northeast of the southwestern property boundary line of the property presently known as "Fairview" Guildford Road, Alfold.
