

**The Surrey County Council**  
**A31 Alton Road, Farnham**  
**(Prohibition of Right Turns and U-Turns) Order 202-**

SURREY COUNTY COUNCIL propose to make under Sections 1(1) and 2(1) to (3) of the Road Traffic Regulation Act 1984, the above mentioned Order, the effect of which will be to: - **1.** Prohibit traffic that is proceeding south-eastward on D5328 Chamber Lane, Farnham, upon reaching its junction with A31 Alton Road, from making a Right-Turn through the gap in the central reservation situate opposite the junction with D5328 Chamber Lane, into A31 Alton Road south-westbound carriageway. **2.** Prohibit traffic that is proceeding north-eastward on A31 Alton Road, Farnham, upon reaching its junction with D5328 Chamber Lane from making a U-Turn through the gap in the central reservation situate opposite the junction with D5328 Chamber Lane, so as to face or proceed in the opposite direction. **3.** Prohibit traffic that is proceeding south-eastward on "X31 Access to Properties, Alton Road, Farnham", upon reaching its junction with A31 Alton Road, from making a Right-Turn through the gap in the central reservation situate opposite the junction with "X31 Access to Properties, Alton Road, Farnham" into A31 Alton Road south-westbound carriageway. **4.** Prohibit traffic that is proceeding north-eastward on A31 Alton Road, Farnham, upon reaching its junction with "X31 Access to Properties, Alton Road, Farnham", from making a U-Turn through the gap in the central reservation situate opposite the junction with "X31 Access to Properties, Alton Road, Farnham", so as to face or proceed in the opposite direction.

The above restrictions shall not apply to vehicles being used for ambulance, fire brigade or police purposes in an emergency; or in relation to anything done with the permission or at the direction of a police constable in uniform; or in accordance with any restriction or requirement indicated by traffic signs placed on the road by or on behalf of Surrey Police.
