

**The Surrey County Council
Various Roads in Ashtead
(20 mph Speed Limit Zone) Order 202-**

Surrey County Council Propose to make the above named Order, under Section 84 of the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers, the effect of which will be to impose a 20 mph speed limit on the lengths of roads in Ashtead specified in the Schedule to this Notice. The speed limit proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011. This Notice supersedes those relating to the same roads dated 20 October 2022 and 19 October 2023, the proposals being amended to sign the proposed speed limits as a zone.

If you wish to object to, or make representations relating to, the proposed Order, you must send the grounds for your objection or representation (including any in support), by (1) using the online form via the webpage quoted above; or (2) in writing to the undersigned at Hazel House, Merrow Lane, Guildford, Surrey GU4 7BQ by **20 June 2024**.

Schedule – **(1)** Grange Road (D2575) the entire length; **(2)** Ottways Lane (D2575) from its junction with Grange Road to the common property boundary between Nos. 41 and 43 Ottways Lane; **(3)** Harriots Lane (D2584) the entire length; **(4)** Chantrey Close (D2584) the entire length; **(5)** The Priors (D2584) the entire length; **(6)** Grangemount (D2575) the entire length; **(7)** Blades Close (2575) the entire length **(8)** Orchard Drive (D2575) the entire length except the private section; **(9)** Taleworth Close (D2575) Ashtead the entire length; **(10)** Taleworth Road (D2575) Ashtead, the entire length except the private section.
