

Surrey County Council
Amendments to Waiting and Parking Restrictions
In the Borough of Elmbridge
(Beauchamp Road and Seymour Road, Molesey)

On 24 November 2023 Surrey County Council (“the Council”) proposed to make the following order under Sections 1, 2, 4, 32, 35, 36, 45, 46, 49, 51, and 53 of and Part IV of Schedule 9 the Road Traffic and Regulation Act 1984 (“the Act”): -

The Surrey County Council (Various Roads in Elmbridge) (Waiting Loading and Unloading Restriction and On-Street Parking Places Orders) (amendment No. 3) Order 202-. The Council proposes further amendments to the following Orders: **(1)** The Surrey County Council (Various Roads in Elmbridge) (Revocation and Consolidation of Waiting, Loading and Unloading Prohibition and Restriction) Order 2021; **(2)** The Surrey County Council (Various Roads in the Borough of Elmbridge) (Consolidation and Revocation of Prohibition of Stopping Outside Schools) Order 2021; so as to make the following provisions: -

- (a) Prohibit the waiting by vehicles at any time in certain lengths of Beauchamp Road and Seymour Road, Molesey, at the junction of the said roads;
- (b) Provide that the usual exemptions, for loading on and unloading from vehicles, boarding and alighting from vehicles, for works on or adjoining the said lengths of roads, the maintenance of those roads and the services in them and for disabled persons vehicles in accordance with the Blue Badge Scheme, would apply;
- (c) Revoke the school keep clear restrictions (Monday-Friday 8.15am-9.15am and 2.30pm-4pm) in Beauchamp Road, West Molesey, to be replaced by a Zebra Crossing and associated keep clear markings.
