Surrey County Council propose to make the above-named Order, under section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, the effect of which will be to

- (1) impose a 20 miles per hour speed limit in the lengths of roads specified and described in the First Schedule to this Notice; and
- (2) impose a 30 miles per hour speed limit in the lengths of roads specified and described in the Second Schedule to this Notice

The speed limit proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.
