SURREY COUNTY COUNCIL - BOROUGH OF GUILDFORD

PROPOSED REDUCTION OF THE EXISTING 60 MPH SPEED LIMIT TO A 20

MPH SPEED LIMIT ON THE ENTIRE LENGTH OF CHALK LANE (D262) AT

EAST HORSLEY AND LEGAL DRAFTING AMENDMENTS REGARDING THE

EXISTING 30 MPH SPEED LIMIT ON CERTAIN LENGTHS OF EAST LANE

(C41), OCKHAM ROAD NORTH (B2039) AND OCKHAM ROAD SOUTH (B2039)

IN THE EAST AND WEST HORSLEY AND OCKHAM AREAS

1. SURREY COUNTY COUNCIL ("THE COUNTY COUNCIL") PROPOSE TO MAKE The Surrey County Council Chalk Lane (D262) East Lane (C41) Ockham Road South (B2039) and Ockham Road North (B2039) in the Parishes of East Horsley West Horsley and Ockham in the Borough of Guildford (20 mph and 30 mph Speed Limits and Part Revocation and Amendment) Order 202- under Sections 81, 82, 83 and 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") (as amended) and of all other enabling powers the purpose and effect of which will be to -

- (a) reduce the existing national speed limit of 60 mph for single carriageway roads to a maximum speed limit of 20 mph on the entire length of Chalk Lane (D262) at East Horsley; and
- (b) revoke the existing 30 mph speed limit imposed by The Surrey County Council Various Roads in the Parish of West Horsley (30 mph Speed Limit) Order 2002 ("the Order of 2002") on the length of East Lane (C41) described in the Schedule to this Notice and The Surrey County Council Ockham Road North (B2039) Ockham Road South (B2039) and The Drift (D246) East Horsley (Restricted Roads and 40 mph Speed Limit) (Amendment) Order 2003 ("the Order of 2003") on the lengths of Ockham Road North (B2039) and Ockham Road South (B2039) described in the Schedule to this Notice -

(NOTE - The lengths of East Lane (C41), Ockham Road North (B2039) and Ockham Road South (B2039) referred to immediately above will continue to remain subject to a 30mph maximum speed limit by virtue of the street lighting system currently provided on those lengths of roads).

2. The proposed Speed Limit Order referred to in paragraph 1 above includes an exemption in respect of vehicles being used by special forces in accordance with the provisions of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 (S.I. 2011/935) ("the Regulations of 2011") from the 20mph speed limit proposed to be imposed by the aforesaid proposed Speed Limit Order.

3. A copy of the proposed Speed Limit Order, together with two plans showing the road and lengths of roads to which that proposed Order relates, The Surrey County Council Various Roads in the Parishes of East Horsley and West Horsley (40 mph Speed limit) Order 2001 (“the Order of 2001”), the Order of 2002, the Order of 2003, the Regulations of 2011, a Statement of the County Council's reasons for proposing to make the Order and a Statement of the County Council's Guidelines for the Acceptance of Objections to Traffic Regulation Orders may be inspected, free of charge -

- (iii) at Guildford Library, 77 North Street, Guildford, Surrey, GU1 4AL on Mondays, Wednesdays and Fridays between 9.30 a.m. and 5.30 p.m., on Tuesdays and Thursdays between 9.30 a.m. and 7 p.m. and on Saturdays between 9.30 a.m. and 5 p.m.; or
- (iv) at Horsley Library, Station Parade, Ockham Road South, East Horsley, Leatherhead, Surrey KT24 6QR on Mondays between 2 p.m. and 5 p.m., on Tuesdays, Thursdays and Fridays between 10 a.m. and 1 p.m. and 2 p.m. and 5 p.m. and on Saturdays between 10 a.m. and 4 p.m.

SCHEDULE

East Lane (C41), that length which extends from the south-western kerb-line of Ockham Road North (B2039) south-westwards to the lamp column numbered and lettered “N1” in East Lane (C41) (situated at a point 16 metres south-west from the south-western kerb-line of Ockham Road North (B2039)).

Ockham Road North (B2039), that length which extends from its junction with Ockham Road South (B2039) (at the Bridge which carries the New Guildford Railway Line over both Ockham Road North and Ockham Road South (B2039)) north-westwards to the lamp column numbered and lettered “N1” on Ockham Road

North (situated at a point 41 metres north-west of the north-western kerb-line of East Lane (C41)).

Ockham Road South (B2039), those lengths which extend -

- (a) from its junction with Ockham Road North (B2039) (at the bridge which carries the New Guildford Railway Line over both Ockham Road North and Ockham Road South (B2039)) southwards and then south-eastwards to the lamp column numbered and lettered "N13" on Ockham Road South (B2039) (situated at a point 17 metres north-west of the north-western kerb-line of Old Rectory Lane); and
- (b) from the unnumbered and unlettered lamp column on Ockham Road South (B2039) (situated at a point 9 metres south-east of the common boundary of the properties known as "Foxmead" and "Tiltwarren", Ockham Road South southwards to the lamp column numbered and lettered "N8" on Ockham Road South (B2039) (situated at a point 8 metres south of the southern kerb-line of Lynx Hill); and
- (c) from the lamp column numbered and lettered "N7" on Ockham Road South (B2039) (situated on the common boundary between the properties known as "Kantara" and "Wiston", Ockham Road South southwards to a point 41 metres north of the northern kerb-line of the A246 Guildford Road (the termination point of the existing 40 mph speed limit in Ockham Road South imposed by the Order of 2001).
