LIMIT ON A LENGTH OF THE C71 CHURCH ROAD, HORNE AND A LEGAL

DRAFTING AMENDMENT AFFECTING THE EXISTING 40 MPH SPEED LIMIT ON THAT

<u>ROAD</u>

1. SURREY COUNTY COUNCIL ("THE COUNTY COUNCIL") PROPOSE TO MAKE The Surrey County Council ((Various Roads in Tandridge and Mid Sussex) (Restricted Roads 20 mph 40 mph and 50 mph Speed Limits) Order 2003) (Amendment No. 14) Order 202- under Sections 81, 82, 83 and 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended by the Local Government Act 1985, the New Roads and Street Works Act 1991, the Road Traffic (Temporary Restrictions) Act 1991, the Deregulation and Contracting Out Act 1994 and the Transport Act 2000 and of all other enabling powers, the purpose and effect of which will be to -

- (a) reduce the existing maximum speed limit of 40 mph to a maximum speed limit of 30 mph on that length of Church Road (C71), Horne which extends from a point 5 metres south of the southern property boundary line of the property known as "No. 4 Homefield Cottages", Church Road, Horne northwards, then north-eastwards and then eastwards to a point 19.5 metres west of the centre line of Hornecourt Hill (C65) (at its junction with Church Road/Whitewood Lane (C71)), a distance of approximately 550 metres;
- (b) carry out a legal drafting amendment regarding the existing 40 mph speed limit on Church Road (C71), Horne, which will not affect that 40 mph speed limit in any way whatsoever, except as provided for in sub-paragraph (a) above; and
- (c) include an exemption in respect of vehicles being used by special forces in accordance with the provisions of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 (S.I. 2011/935) from any speed limit proposed to be imposed by the Speed Limit Order referred to in paragraph 1 above.
