Notice Surrey County Council

(Various Roads in Mole Valley) (Ranmore Common Area) (30mph) Order 202-

Surrey County Council propose to make the above named Order, under Section 84 of the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers, the effect of which will be to:- (a) impose a 30mph speed limit in the length of road specified in Schedule 1 to this Notice; and (b) impose a 20mph speed limit in the length of road specified in Schedule 2 to this Notice.

The speed limits proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011. A copy of the proposed Order, a plan showing the lengths of roads to which the Order relates, and a Statement of the Council's reasons for proposing to make the Order and a Statement of the Council's guidelines on the acceptance of objections to Traffic Regulation Orders may be viewed:

Schedule 1 (30mph speed limit)

- Chapel Lane (D2530) Bookham/Westhumble that length which extends from its junction with Polesden Road and a point 100m west of its junction with Adlers Lane;
- Critten Lane (C43) Effingham that length which extends from its junction with Crocknorth Road to its junction with Public Byway open to all traffic No.137 (Effingham), otherwise known as D263 Drove Road;
- 3. Dorking Road (D2530) Bookham that length which extends from its junction with Polesden Road to the southern property boundary line of Kenilworth Lodge;
- 4. Ranmore Common Road (D271) Westhumble its entire length;
- 5. White Down Lane (C43) Abinger its entire length.

Schedule 2 (30mph speed limit)

- 1. Hogden Lane (D269) Bookham/Ranmore Common -
 - (a) that length which extends from its junction with High Barn Road to its junction with Public Byway open to all traffic No.98 (Wotton), otherwise known as D270 Hogden Lane;
 - (b) that length which extends from its junction with the east to west arm of D269 Hogden Lane to its junction with Ranmore Common Road.
