Proposed Traffic Calming Measures in
Cronks Hill (D1250) Reigate and Somerset Road (D1250) Redhill

Notice is hereby given that Surrey County Council, in exercise of their powers under Section 90(A) to (I) inclusive of the Highways Act 1980, and after consultation with the Chief Officer of Police in accordance with Section 23(2)(A) of the said Act 1984, propose to introduce physical measures to improve safety in Cronks Hill (D1250) Reigate and Somerset Road (D1250) Redhill as follows: -

- (a) Cronks Hill (D1250) Reigate – a tapered edge raised table the centreline of which will be located 33.7 metres northwest of its junction with (D1250) Cronks Hill Road. The proposed raised table will measure 75mm in height, 5.15 metres wide with tapered edges at a 1:3 gradient. It will be 10.5 metres overall in length with a 7.5 metre flat top and 1.5 metre main ramps at a gradient of 1:20.
- (b) Somerset Road (D1250) Redhill – a tapered edge raised table the centreline of which will be located 40.4 metres southeast of its junction with (D1250) Cronks Hill Road. The proposed raised table will measure 75mm in height, 5.6 metres wide with tapered edges at a 1:3 gradient. It will be 10.5 metres overall in length with a 7.5 metre flat top and 1.5 metre main ramps at a gradient of 1:20
