

Surrey County Council
Amendments to Waiting and Parking Restrictions
in the District of Tandridge

Surrey County Council propose to make the following orders under Sections 1(1), 2 (1) to (3), 4(2), 32, 35, 36, 45, 46, 47, 48, 49, 51, 52 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"): -

1. "The Surrey County Council (Various Roads in Tandridge) (Revocation and Consolidation of Waiting Loading and Unloading Prohibitions and Restrictions) Order 2006 (Amendment No. 15) Order 202-" which will amend "The Surrey County Council (Various Roads in Tandridge) (Revocation and Consolidation of Waiting Loading and Unloading Prohibitions and Restrictions) Order 2006", so as to
 - (a) amend the length of the waiting restrictions in certain lengths of the roads as specified in the Schedule to this Notice on the days and during the times specified in the said Schedule; Exemptions for loading on and unloading from vehicles, boarding and alighting from vehicles, using vehicles for works on or adjoining the lengths of roads referred to in the Schedule, the maintenance of those roads and the services in them and for disabled persons' vehicles in accordance with the Blue Badge Scheme, will apply to the afore-mentioned restrictions.
 - (b) prohibit the waiting by vehicles for the purpose of loading and unloading from vehicles in certain lengths of Croydon Road, Caterham between the hours of 8.30am and 10am and 4pm and 6pm Monday to Friday. (N.B disabled persons' vehicles in accordance with the Blue Badge Scheme will not be exempt from these restrictions)
2. "The Surrey County Council (Various Roads in Tandridge) (Consolidation of Free Street Parking Places) Order 2006 (Amendment No.15) Order 202-" which will amend "The Surrey County Council (Various Roads in Tandridge) (Consolidation of Free Street Parking Places) Order 2006" so as to amend the lengths and locations of the time limited free street parking places on Croydon Road, Caterham, this will have effect as to reduce the length of available space from 152.5 metres to 124.2 metres. These free street parking places will be subject to the existing restrictions of Monday to Saturday 8.30am – 6pm, 1 hour only with no return within 3 hours.
3. "The Surrey County Council (Various Roads in Tandridge) (Consolidation of Free Street Parking Places) (Disabled Persons) (No.1) Order 2006 (Amendment No.15)

Order 202-” which will amend “The Surrey County Council (Various Roads in Tandridge) (Consolidation of Free Street Parking Places) (Disabled Persons) (No.1) Order 2006” so as to

- (a) revoke the existing disabled persons’ on-street parking places located outside no’s 41 and 44 Croydon Road
- (b) provide two disabled persons’ on-street parking places outside no’s 53 and 55 Croydon Road subject to the existing time limited restriction of 3 hours with no return within 1 hour.
- (c) provide that certain other vehicles may wait in any of the disabled persons’ on-street parking places in certain circumstances e.g. to allow persons to board or alight (maximum 2 minutes) to load or unload (20 minutes), etc.

4. “The Surrey County Council (Various Roads in Tandridge) (Free On-Street Loading Bays) Order 2024 (Amendment No.1) Order 202-” which will amend “The Surrey County Council (Various Roads in Tandridge) (Free On-Street Loading Bays) Order 2024” so as to

- (a) provide a loading bay in a certain length of Croydon Road, Caterham for loading on and unloading from goods vehicles, to be operational at all times, subject to certain exemptions such as for emergency vehicles, or where necessary for works
- (b) Provide that certain other vehicles may wait in the free on-street loading bay referred to above in certain circumstances e.g. to allow persons to board or alight (maximum 2 minutes), etc.

5. The Council also proposes to make “The Surrey County Council (Various Roads in Tandridge) Electric Vehicle Parking Places Order 202-”, under Sections 32, 35 and 36 of the Act, which will introduce such electric vehicle on-street parking places in certain lengths of Croydon Road, Caterham, subject to the time limited restriction of Monday to Saturday 8.30am – 6pm, 2 hours with no return within 3 hours. To be used by electric vehicles or hybrid vehicles for the purpose of charging the said vehicle by use of the electric charging post installed in respect of that parking place; Certain other vehicles may wait in such parking places in certain circumstances e.g. to allow persons to board or alight (maximum 2 minutes) to load or unload (maximum 20 minutes), etc. but no exemption shall apply to blue badge holders.

6. Where a new restriction is proposed in this Notice, any existing restriction on the same length of road shall be revoked.
7. The following Orders are also proposed, the effect of which will be to make legal drafting amendments to the specified Orders which will not affect the operation of the prohibition and restrictions on the ground: -
 - (a) "The Surrey County Council Various Roads in the District of Tandridge (Residents' On-Street Parking Place) Order 2019 (Amendment No.5) Order 202-" which will amend "The Surrey County Council Various Roads in the District of Tandridge (Residents' On-Street Parking Place) Order 2019";
 - (b) "Surrey County Council (Various Roads in Tandridge) (Prohibition of Waiting of Heavy Commercial Vehicles) Order 2022 (Amendment No.2) Order 202-" which will amend "Surrey County Council (Various Roads in Tandridge) (Prohibition of Waiting of Heavy Commercial Vehicles) Order 2022";
 - (c) "The Surrey County Council (Various Lay-Bys in Tandridge and Westway (D1399) Caterham on the Hill) (Free On-Street Parking Places) Order 2006 (Amendment No.15) Order 202-" which will amend "The Surrey County Council (Various Lay-Bys in Tandridge and Westway (D1399) Caterham on the Hill) (Free On-Street Parking Places) Order 2006".
 - (d) "The Surrey County Council (Various Roads in Tandridge) (Prohibition of Stopping Outside Schools) (No.1) Order 2008 (Amendment No.14) Order 202-" which will amend "The Surrey County Council (Various Roads in Tandridge) (Prohibition of Stopping Outside Schools) (No.1) Order 2008"
