

**Notice**  
**The Surrey County Council**  
**(Various Roads in East Molesey)**  
**(20Mph Speed Limit Zone) Order 202-**

Surrey County Council propose to make the above-named Order, under section 81, 82, 83 and 84 of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, the effect of which will be to impose a 20mph speed limit on the lengths of roads specified and described in the Schedule to this Notice, which will be signed as a 20mph zone.

The speed limit proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011
