

**Notice**  
**The Surrey County Council**  
**(Various Roads in Ewell)**  
**(20Mph Speed Limit) Order 202-**

On 15 February 2024 Surrey County Council gave Notice that the council proposed to make the above-named Order under section 81, 82, 83 and 84 of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers the effect of which was to impose a 20mph speed limit on the lengths of road specified and described in the Schedule to that Notice. Surrey County Council now gives Notice that it proposes to make the said Order with the modifications described in this Notice. These modifications are to impose a 20mph speed limit on the revised lengths of road specified and described in the Schedule to this Notice.

The speed limit proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011
