

Notice – The Surrey County Council

Proposed Amendments to Waiting, Loading and Unloading Prohibition and On-Street Parking Places in D3282 Fairfield Avenue, Staines Upon Thames

Surrey County Council (“the Council”) propose to make “The Surrey County Council (Various Roads in the Borough of Spelthorne) (Waiting Loading and Unloading Prohibition and On-Street Parking Places Orders) (Amendment No. 2) Order 202 - , under Sections 1, 2, 4, 32, 35, 36, 45, 46, 49, 51, and 53 of and Part IV of Schedule 9 the Road Traffic and Regulation Act 1984 (“the Act”) the purpose and effect of which will be to make amendments to: - **(1)** The Surrey County Council (Various Roads in Spelthorne) (Revocation and Consolidation of Waiting, Loading and Unloading Prohibition and Restriction) Order 2024, **(2)** The Surrey County Council (Various Roads in Spelthorne) (Consolidation and Revocation of On-Street Car Club Parking Places) Order 2024, so as to: -

(a) Prohibit the waiting by vehicles at any time in that length of the northern access road (Eden Grove, Staines Upon Thames) leading to the development, extending either side of the of the junction, opposite The Oaks; and provide that the usual exceptions for loading and unloading vehicles, boarding and alighting from vehicles, for works on or adjoining the lengths of roads referred to in the said schedule, the maintenance of those roads and the services in them and for disabled persons vehicles in accordance with the Blue Badge Scheme, would apply.

(b) Provide 6 new car club bays CC-702 in D3282 Fairfield Avenue, Staines Upon Thames, situated opposite “No.1-28 Linden Place”, from a point in-line with the northern kerb-line of the access road leading to Linden Place northwards for 33.74m.

(c) Provide for a loading bay, at any time, situated opposite “No.1-28 Linden Place”, from a point in-line with the northern kerb-line of the access road leading to Linden Place southwards for 21.39m.

Make certain amendments to the following existing Orders which impose waiting, loading and unloading and parking prohibitions and restrictions in the Borough of Spelthorne, which will not affect the operation of those prohibitions and restrictions: - **(1)** Surrey County Council (Various Roads in Spelthorne) (Consolidation and Revocation of Free Street Parking Places) Order 2024, **(2)** The Surrey County Council (Various Roads in Spelthorne) (Consolidation and Revocation of Free Street Parking Places) (Disabled Persons) Order 2024, **(3)** The Surrey County Council (Various Roads in Spelthorne) (Consolidation and Revocation of Residents’ Only On-Street Parking Places) Order 2024, **(4)** The Surrey County Council (Various Roads in Spelthorne) (Consolidation and Revocation of Prohibition of Stopping Outside Schools) Order 2024, **(5)** The Surrey County Council (Various Roads in Spelthorne) Electric Vehicle Parking Places Order 2024, **(6)** The Surrey County Council (Various Roads in Spelthorne) (Consolidation and Revocation of Prohibition of Waiting of Heavy Commercial Vehicles) Order 2024, **(7)** The Surrey County Council (Borough of Spelthorne) (Consolidation and Revocation of Solo Motor Cycle Parking Places Order 2024, **(8)** The Surrey County Council (Borough of Spelthorne) (Church Road, Ashford) (Consolidation and Revocation of Free On-Street Parking Places for Police Vehicles) Order 2024; and **(9)** The Surrey County Council (Elmsleigh Road Staines-Upon-Thames) Loading Bays Order 2024. Where a new restriction in this Notice is proposed, any existing restriction on the same length of road shall be revoked, unless otherwise stated.
