Surrey County Council Imposition of 20mph Speed Limit in Alma Lane, Upper Hale Road and Wings Road, Farnham

- Surrey County Council ("County Council") propose to make "Surrey County Council (Various Roads in Farnham Town Centre) (20mph Speed Limit) Order 202-", under Section 84 of the Road Traffic Regulation Act 1984 "the Act" (as amended) and all other enabling powers, the effect of which will be to impose a 20mph speed limit in the lengths of roads specified in the **Schedule** to this Notice.
- 2. The 20mph speed limit imposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.
- 3. Schedule (20mph Speed Limit)

- 1. Upper Hale Road, Farnham from a point 87 metres south of the centre point of its junction with Wood Road to a point 164 metres west of the centre point of its junction with Spring Lane;
- 2. Alma Lane, Farnham from its junction with Upper Hale Road north for a distance of 80 metres;
- 3. Wings Road, Farnham from its junction with Upper Hale Road, south-west for a distance of 26 metres.
