PROPOSED TRAFFIC CALMING MEASURES
IN FIR TREE ROAD (D4026), CEDAR WAY (D4026) AND CYPRESS ROAD
(D4026) GUILDFORD

SURREY COUNTY COUNCIL in exercise of their powers under Section 90(A) to (I) of the Highways Act 1980 propose to introduce a series of vertical traffic calming features in Fir Tree Road (D4026), Cedar Way (D4026) and Cypress Road (D4026) Guildford. The types of physical measures and its locations are as follows –

- (a)** 1 flat-topped speed cushion in Fir Tree Road (D4026) Guildford, the centre line of which will be situated at a point 1m south-east of the common boundary of property Nos. 98 and 100 Fir Tree Road. The speed cushion will be 1.7m wide, 75mm in height and 3m in length;
- (b)** A pair of flat-topped speed cushions in Fir Tree Road (D4026) Guildford, the centre line of which will be situated at a point 4m north of the common boundary of property Nos. 65 and 67 Fir Tree Road. Each cushion will be 1.6m wide, 75mm in height and 3m in length;
- (c)** A pair of flat-topped speed cushions in Cypress Road (D4026) Guildford, the centre line of which will be situated at a point 11m east of the common boundary of property Nos. 106 and 108 Cypress Road. Each cushion will be 1.7m wide, 75mm in height and 3m in length;
- (d)** A pair of flat-topped speed cushions in Cedar Way (D4026) Guildford, the centre line of which will be situated at a point 10m south-east of the common boundary of Nos. 62 and 64 Cedar Way. Each cushion will be 1.6m wide, 75mm in height and 3m in length;
- (e)** A pair flat topped-speed cushions in Cypress Road (D4026) Guildford, the centre line of which will be situated at a point in-line with the common boundary of property Nos. 16 and 18 Cypress Road. Each cushion will be 1.7m wide, 75mm in height and 3m in length.
