(20 mph Speed Limit) Order 202-**

SURREY COUNTY COUNCIL in exercise of their powers under Section 84 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1 THIS Order may be cited as "The Surrey County Council Various Roads in the Borough of Guildford (20 mph Speed Limit) Order 202-" and shall come into operation on ***
 - 2 (1) In this Order unless the context otherwise requires the following expressions shall have the same meanings hereby respectively assigned to them –

“enactment” means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment

“motor vehicle” has the same meaning as in Section 136 of the Act
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
 - (3) Any reference in this Order to a numbered Article shall unless the context otherwise requires be construed as a reference to the Article bearing that number in this Order
- 3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this

Order no person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the lengths of roads specified in The Schedule to this Order

- 4 NO speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(4) of those Regulations

- (h) the entire length of Artillery Terrace (D4005), Guildford
- (i) the entire length of Artillery Road (D4005), Guildford
- (j) the entire length of Stoke Fields (D4004), Guildford
- (k) the entire length of Stoke Grove (D4004), Guildford
- (l) the entire length of Church Road (D4005), Guildford
