Notice Surrey County Council

(Various Roads in Guildford, Mole Valley and Waverley) (Rural Area Speed Limits Area 2) (20mph, 30mph and 40mph Speed Limits) (No. 2) Order 202-

Surrey County Council propose to make the above named Order, under Section 84 of the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers, the effect of which will be to:- (a) impose a 20mph speed limit in the length of road specified in Schedule 1 to this Notice; and (b) impose a 30mph speed limit in the length of road specified in Schedule 2 to this Notice; (c) impose a 40mph speed limit in the length of road specified in Schedule 3 to this Notice; (d) carry out legal drafting amendments to "The Surrey County Council Abinger Lane (C43) Sutton Lane (D281) Evelyn Cottages (D571) Abinger (20mph and 30mph Speed Limit) Order 2021" so as to revoke the 30mph speed limit in Abinger Lane (C43) Abinger; (e) carry out legal drafting amendments to "The Surrey County Council Various Roads in the District of Mole Valley (40 MPH Speed Limit) Order 2018" so as to revoke the 40mph speed limit in Donkey Lane (D281) Abinger; and (f) carry out legal drafting amendments to "The Surrey County Council (Various Roads in the Oakwoodhill Area in the Parishes of Abinger and Ockley in the District of Mole Valley) (40mph Speed Limit) Order 2005" so as to revoke the 40mph speed limit in part of Honeywood Lane (C50) Okewood Hill and part of Okewood Hill (D293) Okewood Hill and the entire length of Okewood Hill (C50) Okewood Hill.

The speed limits proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011. - 1. Abinger Lane (C43) Abinger between its junction with Raikes Lane and a point 16m north-west of the north-west boundary of Rew Cottage;
- 2. Donkey Lane (D281) Abinger its entire length;
- 3. Radnor Lane (D275) Holmbury St Mary, part of which is known as Byway open to all traffic No. 513 (Shere) its entire length;
- 4. Water Lane (D281) Abinger Hammer its entire length;
- 5. Raikes Lane (C43/D274) Abinger Hammer its entire length;
- 6. Sutton Lane (D281) Abinger between its junction with B2126 Horsham Road and a point 67m west of the entrance to Abinger Manor;
- 7. Wollards Road (D291) Forest Green its entire length;
- 8. Felday Glade (D277) Holmbury St Mary between its junctions with B2126 Horsham Road and the property boundary line between property No. 4 Holmdale Cottages, Felday Glade and and property No. 4 Felday Glade;
- 9. Pitland Street (D280) Holmbury St Mary its entire length;
- 10. Hoe Lane (D230) Abinger Hammer/Peaslake its entire lengths;
- 11. Holmbury Hill Road (D280) Holmbury St Mary its entire length.

Schedule 2 (30mph speed limit)

- 1. Pasture Wood Road (D280) Abinger its entire length;
- 2. Honeywood Lane (C50) Okewood Hill between its junction with C50 Okewood Hill and 100m south of its junction with the entrance to Woodhams Farm:
- 3. Okewood Hill (C50) Okewood Hill its entire length;
- 4. Okewood Hill (D293) Okewood Hill between its junction with Honeywood Lane and a point 13m east of the eastern kerb-line of Public Footpath No. 83 (Abinger);
- 5. Ruckmans Lane (D293) Okewood Hill its entire length.

Schedule 3 (40mph speed limit)

1. Cotton Row (D279) Holmbury St Mary – its entire length.
