

**Proposed reduction of the existing 40mph Speed Limit to a 30mph Speed Limit on a  
length of A322 Guildford Road, Bisley/West End**

**D31 Queens Road, Bisley and C12 Limecroft Road, Bisley/Knaphill**

Surrey County Council propose to make “The Surrey County Council A322 Guildford Road, Bisley/West End, D31 Queens Road, Bisley and C12 Limecroft Road, Bisley/Knaphill (Revocation and Amendment) Order 20- ” under Sections 81, 82, 83 and 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) (“the 1984 Act”) and of all other enabling powers, the purpose and effect of which is to reduce the speed limit imposed on the lengths of road described in the Schedule to this Notice from 40mph to 30mph. This proposal will require for the existing 40mph speed limit imposed on the length of A322 Guildford Road, Bisley/West End, D31 Queens Road, Bisley and C12 Limecroft Road, Knaphill referred to above and specified and described in the Schedule to this Notice to be revoked whereby the said lengths of road will then become subject to a 30mph maximum speed limit by virtue of the provision of a system of street lighting, pursuant to Sections 81 and 82(1)(a) of the 1984 Act.

The proposals herein will require for: - **1.** The “Road Traffic Regulation Act 1967 The County Council of Surrey (40 M.P.H. Speed Limit)(No.3) Order 1974” (as amended), to be revoked in its entirety. **2.** The “Road Traffic Regulation Act 1962 The County Council of Surrey (40 M.P.H. Speed Limit)(No.1) Order 1966” (as amended), to be revoked in its entirety. **3.** “The Surrey County Council (A319 Bagshot Road and A322 Guildford Road, West End) (40MPH Speed Limit) Order 2004” (as amended), to be amended so to revoke that part that which imposes the 40mph maximum speed limit on A322 Guildford Road, Bisley and West End which extends from a point 22m north-west of its junction with Brentmoor Road, north-westwards to a point 35m south-east of the roundabout junction of A322 Guildford Road, A322 Lightwater By-Pass, B311 Red Road and A319 Bagshot Road known as the “Gordon Boys Roundabout”. **4.** “The Borough of Surrey Heath (D31 Queens Road, Bisley) (40mph Speed Limit Order) 1997” (as amended), to be amended so to revoke that part that which imposes the 40mph maximum speed limit on D31 Queens Road, Bisley from its junction with A322 Guildford Road, to a point 25m southwest of its junction with Queens Close. **5.** “The County Council of Surrey (40 M.P.H. Speed Limit)(No.2) Order 1974 – Imposition of a 40mph speed limit at Knaphill in the Bagshot Rural District” (as amended), to be revoked in its entirety. **6.** Any Previous Order and any Part to any Previous Order made or having effect as if made, under Sections 81, 82, 83 and 84 of “the 1984 Act” and of all other enabling powers that impose any speed limit on the lengths of road described in the Schedule to this Notice shall be revoked in entirety.

#### **Schedule**

**(i)** A322 Guildford Road, from the existing 30/40mph speed limit change at the borough boundary between Surrey Heath and Woking, northwards to a point 35m south-east of the roundabout junction of A322 Guildford Road, A322 Lightwater By-Pass, B311 Red Road and A319 Bagshot Road known as the “Gordon Boys Roundabout”.

**(ii)** D31 Queens Road, Bisley - from its junction with A322 Guildford Road, south-westwards to a point 25m southwest of the centre of its junction with Queens Close.

**(iii)** C12 Limecroft Road, Bisley/Knaphill - from its junction with A322 Guildford Road, eastwards to the existing 30/40mph speed limit change at the borough boundary between Surrey Heath and Woking
