

Surrey County Council
Amendments to Waiting and Parking Restrictions
In the Borough of Elmbridge – Halfway Green, Walton On Thames

On 24 November 2023 Surrey County Council (“the Council”) proposed to make the following order under Sections 1, 2, 4, 32, 35, 36, 45, 46, 49, 51, and 53 of and Part IV of Schedule 9 the Road Traffic and Regulation Act 1984 (“the Act”), The Surrey County Council (Various Roads in Elmbridge) (Waiting Loading and Unloading Restriction and On-Street Parking Places Orders) (amendment No. 3) Order 202-. The Council now proposes to make amendments to the original proposed Order so as to amend the following Orders: - **(1)** The Surrey County Council (Various Roads in Elmbridge) (Revocation and Consolidation of Waiting, Loading and Unloading Prohibition and Restriction) Order 2021; and **(2)** The Surrey County Council (Various Roads in Elmbridge) (Consolidation and Revocation of Free Street Parking Places and Loading Bays) Order 2021; so as to prohibit the waiting by vehicles in a length of Halfway Green, Walton On Thames (south-east side), at any time, replacing a no waiting Monday-Friday 8am-noon restriction and part of a free parking bay operational Monday-Friday 8am-noon limited to 1 hour no return within 2 hours; subject to the usual exemptions, for loading on and unloading from vehicles, boarding and alighting from vehicles, for works on or adjoining the said length of road, the maintenance of the road and the services in it and for disabled persons vehicles in accordance with the Blue Badge Scheme.
