## Surrey County Council Amendments to Waiting and Parking Restrictions In the Borough of Elmbridge – Hersham Road, Walton-On-Thames

On 25 March 2022 and 8 April 2022, Surrey County Council ("the Council") proposed to make certain amendments to the Orders which impose the waiting, loading and parking restrictions in the Borough of Elmbridge (specified in the said Notices). The Council now proposes to make The Surrey County Council (Various Roads in Elmbridge) (Waiting Loading and Unloading Restriction and On-Street Parking Places Orders) (amendment No. 2) Order 202-, (as further amended) under Sections 1. 2. 4. 32. 35. 36. 45. 46. 49. 51. and 53 of and Part IV of Schedule 9 the Road Traffic and Regulation Act 1984 ("the Act"), so as to prohibit the waiting by vehicles in certain lengths of Hersham Road, Walton-on-Thames (between Hurley Close and No. 30 Hersham Road), at any time; and provide that the usual exemptions, for loading on and unloading from vehicles, boarding and alighting from vehicles, for works on or adjoining the said lengths of roads, the maintenance of those roads and the services in them and for disabled persons vehicles in accordance with the Blue Badge Scheme, would apply. The proposed restrictions will have the effect of revoking certain free parking places (8am-6pm limited to 3 hours no return within 1 hour); and school keep clear restrictions (Mon-Fri 8.15am-9.15am and 2.30pm-4pm).
