## **Surrey County Council**

## Amendments to Waiting, Loading and Unloading Restrictions and Free On-Street Parking Places and Permit Parking in the Borough of Reigate and Banstead

Surrey County Council propose to make "The Surrey County Council (Various Roads in Reigate and Banstead) (Amendment of Waiting Loading and Unloading Prohibition and On-Street Parking Places Orders) Order 2018 (Amendment No. 4) Order 202-" under Sections 1(1), 2 (1) to (3), 4(2), 32, 35, 36, 45, 46, 47, 48, 49, 51, 52 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), the purpose and effect of which will be to make certain amendments to the waiting and parking restrictions in the Borough of Reigate and Banstead as follows:-

- **1. Amend** "The Surrey County Council (Various Roads in Reigate and Banstead) (Prohibition and Restriction of Waiting Loading and Unloading and Revocation) Order 2013" so as to
  - (a) prohibit the waiting by vehicles at any time in that length of West Drive (D1039) Burgh Heath, extending from the new site access being constructed situated at or adjacent to Nos. 9-12 West Drive, extending for a distance distance of 20 metres south and north of the site access along West Drive and opposite the access for a distance of 30 metres on the eastern side of West Drive;
  - (b) provide that the following exemptions shall apply:- (1) for loading on and unloading from vehicles; (2) for boarding and alighting from vehicles; (3) using vehicles for works on or adjoining those lengths of roads specified and the maintenance of those roads and the services in them; (4) for disabled persons vehicles in accordance with the "Blue Badge" scheme.
- 2. Amend "The Surrey County Council (Various Roads in Reigate and Banstead) (Consolidation of Free Street Parking Places and Revocation) Order 2013" so as to –
  - (a) provide such free on-street parking place in the lengths of High Street, Banstead specified and described in Schedule 1 to this Notice, to operate on the days and times specified in the said Schedule;
  - (b) subject to the following conditions and provisions:- (i) specify that the vehicles which may be left in a the free on-street parking places shall be passenger vehicles (8 seats or less), motor cycles, invalid carriages and goods vehicles under 5 tonnes maximum gross weight; (ii) provide that between the permitted hours the period during which vehicles may be left and the period during which any vehicle may not return to the said free onstreet parking places will be as specified in the Schedule; (iii) provide that vehicles left by disabled persons may wait in the parking places in accordance with the Blue Badge Scheme without time limit at any time; (iv) provide that certain other vehicles may wait in the parking places in certain circumstances, e.g., to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc; (v) provide that outside the hours of operation indicated, any vehicle may be left in the parking place for any period without time limit.

- **3. Amend** "The Surrey County Council (Various Roads in Reigate and Banstead) (Free On-Street Loading Bays) Order 2013" so as to
  - (a) provide such free goods' vehicles loading only on-street parking places in the lengths of roads specified and describe in Schedule 2 to this Notice, to operate on the days on the times specified in the said Schedule;
  - (b) provide that the following exemptions shall apply:- (1) for loading on and unloading from vehicles; (2) for boarding and alighting from vehicles; (3) using vehicles for works on or adjoining those lengths of roads specified and the maintenance of those roads and the services in them; (4) for disabled persons vehicles in accordance with the "Blue Badge" scheme.
- **4. Make** certain drafting amendments to the following Orders which will not affect the operation of the prohibitions and restrictions on the ground –
- (a) The Surrey County Council (Various Roads in Reigate Controlled Parking Zone) (Prohibition and Restriction of Waiting, Loading and Unloading and Free Street Parking Places) Order 2013;
- **(b)** The Surrey County Council (Various Roads in Reigate and Banstead) (Prohibition of Stopping Outside Schools) Order 2013;
- (c) The Surrey County Council (Various Roads in Reigate and Banstead) (Free Street Parking Places) (Disabled Persons) Order 2013;
- (d) The Surrey County Council (Various Roads in Reigate and Banstead) (Residents' On-Street Parking Places) Order 2013;
- **(e)** The Surrey County Council (Various Roads in Redhill Controlled Parking Zone) (Prohibition and Restriction of Waiting Loading and Unloading and Free Street Parking Places) Order 2013;
- (f) The Surrey County Council (Gardens Estate Horley Controlled Parking Zone) (Prohibition and Restriction of Waiting and Free Street Parking Places) Order 2013;
- (g) Quality Street and Old Mill Lane Merstham in the Borough of Reigate and Banstead (On-Street Parking Place) Order 2013;
- (h) The Surrey County Council Permit Holders On-Street Parking Place (Permit Zone) in the Borough of Reigate and Banstead Order 2015;
- (i) The Surrey County Council (Various Roads in Redhill Controlled Parking Zone) (Prohibition and Restriction of Waiting Loading and Unloading and Free Street Parking Places) (No.2) Order 2016;
- (j) The Surrey County Council Reigate and Banstead (On-Street Car Club Parking Places Order 2016;
- **(k)** The Surrey County Council (Borough of Reigate and Banstead) On-Street Bus Parking Places Order 2018;
- (I) The Surrey County Council (Various Roads in Reigate and Banstead) (Prohibition of Waiting) (Restricted Zone) Order 2019.
- **5. Where** a new restriction is proposed in this Notice, any existing restrictions on the same length of road shall be revoked.

#### Schedule 1 (Free On-Street Parking Places) – High Street (B2217) Banstead

- (a) Monday to Saturday (inclusive) between 8.30am and 6.30pm, limited to 1 hour no return within two hours that length of High Street (B2217), Banstead which extends from a point 11m south-west from the centre of the junction with Glenfield Road westwards to the existing double yellow lines restrictions, a total of 12m
- (b) Monday to Saturday (inclusive) between 9am and 2pm, limited to 1 hour, no return within 2 hours & Monday to Saturday (inclusive) between 3pm and 6.30pm, limited to 1 hour, no return within 2 hours that length of High Street (B2217) Banstead situated at or adjacent to the south-west of the Waitrose carpark exit, a total of 24.5m

# Schedule 2 (Goods' Vehicles Loading Bay) - High Street (B2217) Banstead

(a) Monday to Saturday (inclusive) between 6am and 9am & Monday to Saturday (inclusive) between 2pm and 3pm – that length of High Street (B2217) Banstead situated at or adjacent to the south-west of the Waitrose carpark exit, a total of 24.5m
