

THE SURREY COUNTY COUNCIL
(CHURCH STREET (D2885) AND HIGH STREET (D2885)
LEATHERHEAD) (PROHIBITION OF TRAFFIC AND ONE-WAY
TRAFFIC) ORDER 2003) (AMENDMENT NO. 4) ORDER 202-

THE SURREY COUNTY COUNCIL in exercise of their powers under Sections 1 (1) and 2 (1) to (3) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order:-

1 THIS Order may be cited as "The Surrey County Council (Church Street (D2885) and High Street (D2885) Leatherhead (Prohibition of Traffic and One-Way Traffic) Order 2003) (Amendment No. 4) Order 202-" and shall come into operation on 202-

2 ANY reference in this Order to any enactment means any enactment whether public general or local and including any order bye-law rule regulation scheme or other instrument having effect by virtue of an enactment and shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Surrey County Council Church Street (D2885) and High Street (D2885) Leatherhead (Prohibition of Traffic) Order 2003 shall have effect as though -

(a) in Article 2 thereof there were added the following expressions which shall have the meanings hereby respectively assigned to them -

" "carriageway" has the same meaning as in Section 329 of the Highways Act 1980

"day" means the period of time which begins with one midnight and ends with the next

"the Leatherhead Street Market" means the market organized by the Mole Valley Chamber of Commerce of Fetcham Park House Lower Road Fetcham Leatherhead Surrey KT22 9HD in High Street (D2885) and/or Church Street (D2885) Leatherhead between 9.00 a.m. and 3.00 p.m. on every Thursday and Saturday (any such day not

being Christmas Day Boxing Day or New Year's Day) by virtue of the powers granted to the said Mole Valley Chamber of Commerce by the Mole Valley District Council as provided for by the enactments hereinafter specified -

- (a) the Charter granted to Leatherhead by King Henry III in A.D. 1248 and confirmed to the Lord of the Manor of Pachenesham Magna in A.D. 1331 to hold a weekly Market and Annual Fair and/or
- (b) The Local Government (Miscellaneous Provisions) Act 1982 in so far as that Act relates to the designation of streets as consent streets for the purposes of street trading and for the issuing of street trading consents in connection therewith and for any other matters' ancillary thereto

"Mole Valley District Council" means the Mole Valley District Council of the Administrative Centre Pippbrook Dorking Surrey RH4 1SJ

"pedal cycle" has the same meaning as in Schedule 1 to the Traffic Signs Regulations and General Directions 2016 (S.I. 2016/362)

"street trading" has the same meaning as in paragraph 1 of Schedule 4 to the Local Government (Miscellaneous Provisions) Act 1982

"week" means the period between midnight on Saturday night and midnight on the succeeding Saturday night"

- (b) in relation to the following expression in paragraph (1) of Article 2 of that Order there was substituted the following meaning in replacement for the meaning currently assigned to that expression -

" "restricted hours" means the period between 10.00 a.m. and 4.30 p.m. inclusive on any day of the week"

- (c) in Article 4 of that Order in the third fourth fifth sixth and seventh lines thereof for the words and figures "PROVIDED ALSO that any vehicle which has entered the restricted area or any part thereof before 10.00 am on any Monday Tuesday Wednesday Thursday Friday or Saturday shall leave the restricted area by means of the junction of High Street Leatherhead and the unnamed road by no later than 10.15

a.m. on the same morning on the same day" there were substituted the words and figures "PROVIDED THAT any vehicle which has entered the restricted area or any part thereof before 10.00 a.m. on any day of the week shall leave the restricted area by means of the junction of High Street Leatherhead and the unnamed road by no later than 10.15 a.m. on the same morning on the same day"

(d) for Article 12 of that Order there was substituted the following Article -

"12 NOTHING in Article 4 shall render it unlawful for -

(a) a person proceeding on foot to push a pedal cycle within the restricted area during the restricted hours or

(b) any person to ride a pedal cycle within the restricted area during the restricted hours provided that that person complies with all the requirements of Article 5"

(e) there was added as Article 14A of that Order the following Article -

"14A NOTHING in Article 4 shall apply to any vehicle which enters and/or proceeds in the restricted area during the restricted hours when goods are being or are to be sold or offered or exposed for sale from that vehicle or from a stall or container by a person who holds a Street Trading Consent issued by the Mole Valley District Council to sell goods from a stationary vehicle or stall or container being used by that person on a pitch situated on Church Street (D2885) and/or High Street (D2885) and which pitch is situated within the area used by and forming part of The Leatherhead Street Market PROVIDED THAT THIS Article only applies to such vehicles or stalls or containers when being used in connection with the holding of the Leatherhead Street Market and for no other street trading purposes whatsoever

AND FURTHER PROVIDED THAT the aforesaid vehicle or vehicles complies or comply with all the requirements of Article 5"

(f) in Article 16 of that Order in the second and third lines thereof for the words and figures "The Surrey County Council Church Street (D2885) and High Street (D2885) Leatherhead (Prohibition of Waiting) (Restricted Zone) Order 2006" there were substituted the words and figures "The Surrey County Council Church Street (D2885)

and High Street (D2885) Leatherhead (Prohibition of Waiting) (Restricted Zone)
Order 2017"
