## **Preamble**

SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) and 2 (1) to (3) and 4 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter called "The Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to The Act hereby make the following Order:-

## **Citation and commencement**

1 THIS Order may be cited as "The Surrey County Council (Various Roads in Mole Valley) (Amendment of Waiting Loading and Unloading Prohibition and On-Street Parking Places Orders) (Amendment No. ) Order 202-" and shall come into operation on 201-

## <u>Interpretation</u>

- 2 (1) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment
  - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
  - (3) Unless the context otherwise requires any expression used in this Order which is also used in any of the relevant Principal Orders shall have the same meaning as in that relevant Principal Order
  - (4) In this Order the expression "the Principal Orders" means The Surrey County Council (Various Roads in Moe Valley) (Revocation and Consolidation of Waiting, Loading and Unloading Prohibition and Restriction) Order 2017, The Surrey County Council (Various Roads in Mole Valley) (Consolidation of Free Street Parking Places and Loading Bays and Revocation) Order 2017, The Surrey County Council (Various Roads in Mole Valley) (Consolidation of Free Street Parking Places) (Disabled Persons) Order 2017, The Surrey County Council (Various Roads in Dorking Town Centre in the District of Mole Valley) (Permit Zone) (On-Street Parking Place) Order 2017, The Surrey County Council Church

Street (D2885) and High Street (D2885) Leatherhead (Prohibition of Waiting) (Restricted Zone) Order 2017, The Surrey County Council (Various Roads in Mole Valley) (Residents' On-Street Parking Places) Order 2017, The Surrey County Council Kingston Road (D2887) Leatherhead (Prohibition of Waiting of Heavy Commercial Vehicles) Order 2017, The Surrey County Council Minchin Close Leatherhead in the District of Mole Valley) (Revocation and Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2017 and The Surrey County Council (Various Roads in Mole Valley) (Prohibition of Stopping Outside Schools) Order 2018

  - (d) The Surrey County Council (Various Roads in Dorking Town Centre in the District of Mole Valley) (Permit Zone) (On-Street Parking Place) Order 2017 shall have effect as though for the List of Plans in the First Schedule to the aforesaid Order there was substituted the List of Plans set out in The Schedule to this Order
  - (e) The Surrey County Council Church Street (D2885) and High Street (D2885) Leatherhead (Prohibition of Waiting) (Restricted Zone) Order 2017 shall have effect as though -
    - (i) in the preamble to that Order in the first line thereof for the words "THE COUNTY COUNCIL OF SURREY" there were substituted the words "SURREY COUNTY COUNCIL"
    - (ii) in paragraph (1) of Article 2 thereof there were added the following

expressions which shall have the meanings hereby respectively assigned to them -

" "carriageway" has the same meaning as in Section 329 of the Highways Act 1980

"day" means the period of time which begins with one midnight and ends with the next

"week" means the period between midnight on Saturday night and midnight on the succeeding Saturday night"

- (iii) in Article 2 thereof there was added the following expression which shall have the meaning hereby respectively assigned to it -
  - " "electronic communications apparatus" has the same meaning as in paragraph (1) of Schedule 2 to the Communications Act 1984 and Sections 106 and 151 of the Communications Act 2003"
- (iv) in relation to the following expressions in paragraph (1) of Article 2 of that Order there were substituted the following meanings in replacement for the meanings currently assigned to them -
  - " "permitted hours" means the period between 8.00 a.m. and 6.00 p.m. inclusive on any day of the week
  - "waiver certificate" means a certificate issued on behalf of the County Council for the purposes of Article 4(i) permitting a specified vehicle to wait in special circumstances on a length or lengths of road or roads where the waiting of that vehicle would otherwise be restricted or prohibited"
- (v) in Article 3 of that Order in the fourth line thereof for the words and figures "between 08.00 hrs and 18.00 hrs Mondays to Saturdays inclusive" there were substituted the words "during the permitted hours"
- (vi) in sub-paragraph (iv) of paragraph (c) of Article 4 of that Order in the third and fourth lines thereof for the words and figures "or of any apparatus provided under the Telecommunications Act 1984" there were substituted the words "or of any electronic communications apparatus"
- (vii) for the List of Plans in the First Schedule to the aforesaid Order there was substituted the List of Plans set out in The Schedule to this Order
- (f) The Surrey County Council (Various Roads in Mole Valley) (Residents' On-Street Parking Places) Order 2017 shall have effect as though -
  - (i) in Column 3 of Part I of the First Schedule to that Order in relation to the entry relating to the letter "M" in Column 1 of that Part of that Schedule for the words "Swan Mill Gardens, Leatherhead" in the said Column 3 of that

- (ii) in Column 2 of Part I of the First Schedule to that Order in relation to the entry relating to the letter "Q" in Column 1 of that Part of that Schedule for the words and figures "Queen Anne's Terrace, all properties and No. 13 Linden Road" in the said Column 2 of that Part of that Schedule there were substituted the words and figures "All properties situated within Queen Anne's Terrace and No. 13 Linden Road, Leatherhead"
- (iii) in Column 3 of Part I of the First Schedule to that Order in relation to the entry relating to the letter "Q" in Column 1 of that Part of that Schedule after the words "Queen Anne's Terrace" in the said Column 3 of that Part of that Schedule there was added the word "Leatherhead"
- (iv) for the List of Plans in the Second Schedule to the aforesaid Order there was substituted the List of Plans set out in The Schedule to this Order
