Surrey County Council Amendments to Waiting and Parking Restrictions High Street, Walton-On-Thames and Beales Lane, Weybridge

On 25 March 2022 and 8 April 2022, Surrey County Council ("the Council") proposed to make certain amendments to the Orders which impose the waiting, loading and parking restrictions in the Borough of Elmbridge (specified in the said Notices). The Council now proposes to make The Surrey County Council (Various Roads in Elmbridge) (Waiting Loading and Unloading Restriction and On-Street Parking Places Orders) (amendment No. 3) Order 202-, (as further amended) under Sections 1, 2, 4, 32, 35, 36, 45, 46, 49, 51, and 53 of and Part IV of Schedule 9 the Road Traffic and Regulation Act 1984 ("the Act"), so as to make the following restrictions-

- (a) Prohibit the waiting by vehicles at any time in certain lengths of High Street, Walton-On-Thames and Beales Lane, Weybridge, subject to the usual exemptions, for loading on and unloading from vehicles, boarding and alighting from vehicles, for works on or adjoining the said lengths of roads, the maintenance of those roads and the services in them and for disabled persons vehicles in accordance with the Blue Badge Scheme;
- **(b)** Prohibit the loading on and unloading from vehicles at any time in a certain length of High Street, Walton-On-Thames;
- **(c)** Provide a goods vehicles' loading bay in High Street, Walton-On-Thames, for loading on and unloading from goods vehicles, operational every day from 8am-6pm, subject to certain exemptions such as emergency vehicles, or where necessary for works;
- (d) Provide a disabled persons' free on-street parking place in High Street, Walton-On-Thames, to operate at all times limited to 3 hours no return within 1 hour, and that, certain other vehicles may wait in the disabled persons' free on-street parking place in certain circumstances e. g. to allow persons to board or alight (maximum 2 minutes) to load or unload (maximum 20 minutes), etc.;
- **(e)** Where a new restriction is imposed in this Notice, any existing restriction on the same length of road will be revoked and the loading bay and disabled persons parking place proposed herein will relocate an existing loading bay and disabled persons' parking place, which will be revoked.
