

Notice - The Surrey County Council

Various Roads in Weybridge Proposed 20 mph Speed Limit Zone

Surrey County Council propose to make “The Surrey County Council Various Roads in Weybridge (20 mph Speed Limit Zone) (and Revocation) Order 202-”, under Section 84 of and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, the effect of which will be to: -

1. Impose a 20 mph speed limit on the entire lengths of the roads in Weybridge specified in the First Schedule to this Notice, that will be signed as a 20mph Zone. **2.** Revoke “The Surrey County Council Various Roads in Weybridge (20mph Speed Limit) Order 2020” that imposes the existing 20mph speed limit in the lengths of road specified in the Second Schedule to this Notice and reimpose the 20mph speed limit in these lengths by inclusion within this proposed Speed Limit Order and Zone. **3.** Revoke “The Surrey County Council Weybridge 20mph Zone (20mph Speed Limit) Order 2007” that imposes the existing 20mph speed limit in the lengths of road specified in the Third Schedule to this Notice and reimpose the 20mph speed limit in these lengths by inclusion within this proposed Speed Limit Order and Zone. (Note – The revocations and reimpositions proposed in Parts 2. and 3. to this Notice will not affect any changes to the existing speed limits imposed on the lengths of road specified in the Second Schedule to this Notice or to the lengths of road specified in the Third Schedule to this Notice therefore responses are only invited for the new proposals described in Part 1. to this Notice).

The speed limits proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.
