

## **Notice – The Surrey County Council**

### **Amendments to Waiting Restrictions in A317 Church Street, Weybridge**

Surrey County Council (“the Council”) propose to make “The Surrey County Council (Various Roads in Elmbridge) (Waiting Loading and Unloading Restriction and On-Street Parking Places Orders) (Amendment No. 4) Order 202-”, under Sections 1, 2, 4, 32, 35, 36, 45, 46, 49, 51, and 53 of and Part IV of Schedule 9 the Road Traffic and Regulation Act 1984 (“the Act”) the effect of which will be to: - Amend “The Surrey County Council (Various Roads in Elmbridge) (Revocation and Consolidation of Waiting, Loading and Unloading Prohibition and Restriction) Order 2021;” so as to prohibit the waiting by vehicles at any time in that length of A317 Church Street, Weybridge that extends from the eastern side of its junction with D3881 Minorca Road, to the eastern side of its junction with the access for Weybridge NHS Health Campus” (north side); and provide that the usual exceptions for loading and unloading vehicles, boarding and alighting from vehicles, for works on or adjoining the lengths of roads referred to in the said schedule, the maintenance of those roads and the services in them and for disabled persons vehicles in accordance with the Blue Badge Scheme, would apply.

Make certain amendments to the following existing Orders which impose waiting, loading and unloading and parking prohibitions and restrictions in the Borough of Elmbridge, which will not affect the operation of those prohibitions and restrictions: - (1) The Surrey County Council Various Roads in the Borough of Elmbridge (Consolidation and Revocation of Controlled Parking Zones) Order 2021; (2) The Surrey County Council Various Roads in the Borough of Elmbridge (Consolidation and Revocation of Residents’ On-Street Parking Places) Order 2021; (3) The Surrey County Council (Various Roads in Elmbridge) (Consolidation and Revocation of Free Street Parking Places and Loading Bays) Order 2021; (4) The Surrey County Council (Various Roads in Elmbridge) (Consolidation and Revocation of Free Street Parking Places) (Disabled Persons) Order 2021; (5) The Surrey County Council (Various Roads in the Borough of Elmbridge) (Consolidation and Revocation of Prohibition of Stopping Outside Schools) Order 2021; (6) The Surrey County Council Various Roads in Elmbridge) (Consolidation and Revocation of Prohibition of Waiting of Heavy Commercial Vehicles) Order 2021; (7) The Surrey County Council (Borough of Elmbridge) (Consolidation and Revocation of Solo Motor Cycle Parking Places) Order 2021; (8) The Surrey County Council Various Roads in the Borough of Elmbridge (Consolidation and Revocation of On-Street Car Club Parking Places) Order 2021; (9) The Surrey County Council (Various Roads in Elmbridge) Electric Vehicle Parking Places Order 2024.
