Proposed Traffic Calming Measures
in Various Roads in Banstead

SURREY COUNTY COUNCIL in exercise of their powers under Section 90(A) to (I) of the Highways Act 1980 propose to introduce a series of physical measures to improve safety and reduce vehicle speeds in the following lengths of roads in Banstead. The type of physical measures and their locations are as detailed below.

- (a) Bolters Lane (B2219) Banstead – a flat-topped, full width road table which will measure 75mm in height, 7.5m in length and 6.3m in width with 1.1m long ramps, the centre line of which will be at a point 79m north of its junction with the circulatory carriageway comprised in the roundabout situated at or adjacent to the junctions with B2219 Holly Lane, D1085 Court Road and B2219 Garratts Lane and B2219 Bolters Lane.
- (b) Court Road (D1085) Banstead – a flat topped road table which will measure 4.5m in length, 3.4m in width with 1.1m long ramps, the centre line of which will be at a point 74m east of its junction with the circulatory carriageway comprised in the roundabout situated at or adjacent to the junctions with B2219 Holly Lane, D1085 Court Road and B2219 Garratts Lane and B2219 Bolters Lane.
- (c) Holly Lane (B2219) Banstead – a flat topped full width road table which will measure 75mm in height, 4.5m in length, 6.3m in width with 1.1m long ramps, the centre line of which will be at a point 66m south of its junction with the circulatory carriageway comprised in the roundabout situated at or adjacent to the junctions with B2219 Holly Lane, D1085 Court Road and B2219 Garratts Lane and B2219 Bolters Lane.
- (d) Holly Lane (B2219) Banstead - a flat topped full width road table which will measure 4.5m in length, 6.3m in width with 1.1m long ramps, the centre line of which will be at a point 121m south of its junction with the circulatory carriageway comprised in the roundabout situated at or adjacent to the junctions with B2219 Holly Lane, D1085 Court Road and B2219 Garratts Lane and B2219 Bolters Lane.
- (e) A raised table at the roundabout junction of B2219 Holly Lane, D1085 Court Road and B2219 Garratts Lane and B2219 Bolters Lane. The table will extend

across the carriageway and will have 1.1m long ramps on each approach, a total area of 917 square metres. It will measure 75mm in height
