

**NOTICE**  
**Surrey County Council**  
**Lumley Road (D351) Horley**  
**(Prohibition of Entry and Revocation) Order 202-**

Surrey County Council in exercise of their powers under Sections 1, 2 and 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 proposed to make the above-mentioned Order. The effect of which will be to:-

- (1) prohibit motor vehicles proceeding in a northerly direction in Lumley Road (D351) Horley from entering that length of the said road situated at a point 49 metres north of its junction with (D353) High Street;
- (2) revoke "The Borough of Reigate and Banstead (Lumley Road, Horley) (Part) (One Way Traffic) Order 1991" in its entirety

The prohibition specified in sub-paragraph (1) above will not apply in relation to - (a) pedal cyclists; (b) a vehicle being used for ambulance fire brigade or police purposes in an emergency; (c) anything done upon the direction or with the permission of a police constable in uniform; or (d) any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to Section 66 or 67 of the Act.
