

NOTICE
Surrey County Council
Albert Road (D350) and High Street (D353) Horley
(One-Way Traffic and Prohibition of Entry) Order 202-

Surrey County Council in exercise of their powers under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 proposed to make the above-mentioned Order. The effect of which will be:-

- (1) that vehicles proceeding in that length of Albert Road (D350) Horley, between its junction with (D1048) Consort Way and its junction with (D353) High Street, shall proceed in a southerly direction only
- (2) that vehicles proceeding in that length of High Street (D353) Horley, between its junction with (D350) Albert Road and its junction with (D351) Lumley Road and (D1048) Consort Way East, shall proceed in an easterly direction only
- (3) that no vehicles proceeding westwards on High Street (D353) Horley shall enter into that length of High Street at its junction with (D351) Lumley Road and (D1048) Consort Way East

These prohibitions specified in sub-paragraphs (1), (2), and (3) will not apply in relation to - (a) pedal cyclists; (a) a vehicle being used for ambulance fire brigade or police purposes in an emergency; (b) anything done upon the direction or with the permission of a police constable in uniform; or (c) any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to Section 66 or 67 of the Act.

The amendments outlined above are proposed as part of the Delivering Change in Horley Town Centre programme. More information on the investment in Horley can be found at www.surreycc.gov.uk/horleytowncentre.
