## The Surrey County Council Various Roads in Horsell, Knaphill and Chobham (50mph 40mph and 20mph Speed Limits and Revocation) Order 202-

Surrey County Council Propose to make the above named Order, under Section 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and all other enabling powers, the effect of which will be to impose –

- (1) A 50mph speed limit on that length of Littlewick Road (C12) Knaphill, as extends from its junction with South Road to its junction with the Horsell Birch Roundabout;
- (2) A 40mph speed limit on the lengths of roads in the First Schedule to this Notice;
- (3) A 20mph speed limit on the lengths of roads in the Second Schedule to this Notice;
- (4) Extend the existing 30 mph speed limit in South Road, Horsell, (imposed by a system of streetlights), from the existing terminal point at the final streetlamp near the car park to The Plough Inn, northeastwards for a distance of 145m.

The speed limits proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011, and will have the effect of revoking (1) The Borough Council of Woking (Chobham Road (A3046) and Shores Road (A245)) (50 mph Speed limit) Order 2001; and (2) Item 3 and Item 4 of the Schedule to The Borough Council of Woking (Various Roads) (50 mph Speed Limit) Order 1998 in their entirety, and amending (3) The Borough Council of Woking (Woodham Lane (A245) Woking) (40 mph Speed Limit) Order 1996; and (4) The Surrey Council Various Roads in Chobham (Speed Limits) Order 2008.
