Surrey County Council
(Jacobs Well Road (D51) Guildford (30mph Speed Limit) Order 202-

Surrey County Council propose to make the above named Order, under Section 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 “the Act” (as amended) and all other enabling powers, the effect of which will be to:-

- (a) amend “The Surrey County Council A320 Woking Road in the Borough of Guildford (40 MPH Speed Limit) Order 2000” (“Order of 2000”) so as to revoke the 40mph speed limit as applies to that length of Jacobs Well Road (D51) Guildford which extends from the prolongation of the eastern kerb-line of A320 Woking Road north-eastwards to a point 500 metres south-west of the southern kerb-line of C14 Clay Lane;
- (b) impose a 30mph speed limit in that length of Jacobs Well Road (D51) Guildford which extends from a point in-line with the eastern kerb-line of A320 Woking Road north-eastwards to a point 500 metres south-west of the southern kerb-line of C14 Clay Lane.

The speed limit proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011. A copy of the proposed Order, a plan showing the length of road to which the Order relates, and a Statement of the Council’s reasons for proposing to make the Order, the Order of 2000 and a Statement of the Council’s guidelines on the acceptance of objections to Traffic Regulation Orders may be viewed:
