Surrey County Council Amendments to Waiting Restriction and Parking Place Orders in the Borough of Spelthorne

On 14 October 2022 Surrey County Council ("the Council") proposed to make amendments to the existing parking and waiting Orders in the Borough of Spelthorne, under Sections 1, 2, 4, 32, 35, 36, 45, 46, 49, 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984. The Council proposes to make further amendments to the following Orders: -

- 1. The Surrey County Council (Various Roads in Spelthorne) (Revocation and Consolidation of Waiting, Loading and Unloading Prohibition and Restriction) Order 2005 (Amendment No. 16) Order 202-, the effect of which will be to revoke the prohibition of waiting by vehicles (1) at any time and (2) Monday-Saturday 7am-7pm, in certain lengths of Knapp Road, Ashford.
- 2. The Surrey County Council (Various Roads in Spelthorne) (Prohibition of Stopping Outside Schools) (No. 1) Order 2006 (Amendment No. 15) Order 202-, the effect of which will be to (a) Prohibit the stopping by vehicles Monday-Friday 8am-5pm, in part of the Knapp Road junction with Village Way, Ashford (south side) as indicated by zig-zag markings on site; (b) the Exemptions shall apply for any person causing a vehicle to stop in order to avoid an accident, or if required to do so by law, anything done with the permission of a police constable in uniform or in accordance with any sign placed by Surrey Police in accordance with Section 66 or Section 67 of the Act, or for any vehicle displaying a valid waiver certificate issued by the Council; (c) Revoke prohibition of stopping by vehicles Monday-Friday 8am-5pm, in Knapp Road (spur leading to Clarendon School), Ashford.

The proposals herein will not affect the Orders originally proposed, other than to make drafting amendments thereto, which do not affect the operation of those prohibitions and restrictions.
