### The Surrey County Council

#### **(The Surrey County Council (Various Roads in Epsom Downs)(40 mph Speed Limit Order 2003) (Part Revocation and 30 mph Speed Limit) Order 202-**

Surrey County Council propose to make the above named Order, under Sections 81, 82, 83 and 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") (as amended) and of all other enabling powers, the purpose and effect of which is to: **1.** Revoke the existing 40mph maximum speed limit imposed by "The Surrey County Council (Various Roads in Epsom Downs)(40 mph Speed Limit Order 2003" on that length of D2251 Langley Vale Road, Epsom Downs which extends from a point 140m south-west of its junction with D2187 Grosvenor Road, to a point 490m south-west of its junction with D2187 Grosvenor Road, 50m south-west of the lamp column lettered and numbered N50. **2.** Impose a 30 mph speed limit in the length of D2251 Langley Vale Road, Epsom Downs that extends from the lamp column lettered and numbered N46 to the lamp column lettered and numbered N47. NOTE - The length of D2251 Langley Vale Road, Epsom Downs referred to above that extends from a point 140m south-west of its junction with D2187 Grosvenor Road, to the lamp column lettered and numbered N47 will become subject to a 30mph maximum speed limit by virtue of the street lighting system currently provided on that length of road. The speed limit proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.
