

Notice - The Surrey County Council

Proposed 20mph and 30mph Speed Limit in B2133 Loxwood Road and D179 Rosemary Lane, Alfold

Surrey County Council propose to make "The Surrey County Council B2133 Loxwood Road and D179 Rosemary Lane, Alfold (20MPH and 30MPH Speed Limit) (Amendment and Part-Revocation) Order 202-" under Section 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, the effect of which will be to: - **1.** Impose a maximum speed limit of 20 miles per hour on the lengths of road specified and described in the First Schedule to this Notice. **2.** Impose a maximum speed limit of 30 miles per hour on the length of road specified and described in the Second Schedule to this Notice. **3.** "The Surrey County Council (Built-Up Areas) (No.1) Order 1937" as amended by "The Surrey County Council (Built-Up Areas) (No.1) Order 1978" and any Previous Order and any Part to any Previous Order made or having effect as if made under Sections 81, 82, 83 and 84 of "the 1984 Act" and of all other enabling powers that impose any speed limit on the lengths of road described in the First Schedule to this Notice and that impose any speed limit on the length of road described in the Second Schedule to this Notice shall be revoked.

The speed limits proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011. FIRST SCHEDULE

- a) That length of B2133 Loxwood Road, Alfold that extends from a point 286.50m north of the county boundary of Surrey County Council with West Sussex County Council to a point 11.70m north of its junction with Hook Street (Alfold Business Centre) (a distance of approx. 530m).
- b) The entire length of D179 Rosemary Lane, Alfold that extends from its junction with B2133 Loxwood Road, to X179 Rosemary Lane.

SECOND SCHEDULE

- a) That length of B2133 Loxwood Road, Alfold that extends from the county boundary of Surrey County Council with West Sussex County Council for a distance of 286.50m (northbound).
