The Surrey County Council Manor Road (D1202) Reigate (Width Restriction) Order 202-

Surrey County Council propose to make the above mentioned Order under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act"). The purpose and effect of the Order will be to prohibit any vehicle the overall width, together with load (if any) carried thereon, exceeds 6 feet 6 inches, from entering or proceeding in the entire length of Manor Road (D1202) Reigate. The prohibition will not apply for vehicles being used for the purpose of gaining access to or leaving the premises or land in or adjacent to the lengths of roads specified above or to vehicles being used:-

- (a) for ambulance, fire brigade or police purposes;
- (b) on the direction, or with the permission, of a police constable in uniform, or in accordance with traffic signs placed by, or on behalf of, the Police;
- (c) in the service of a local authority or of a water authority;
- (d) in connection with the carrying out on land or on premises situate in or adjacent to the road specified in this Notice, of any of the following operations namely –
 - building, industrial or demolition operations, or the maintenance, improvement or reconstruction of the road;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the laying, erection, alteration or repair of any sewer, or of any main pipe or apparatus for the supply of gas, water or electricity, or of any electronic communications apparatus;
 - (iv) for the cleansing or lighting of or the collection of refuse;
 - (v) for the placing, maintenance or removal of any traffic sign;
 - (vi) for the purposes of agriculture on any land adjacent to the said road, or in connection with the conveyance or haulage of timber felled on such land;
 - (vii) to enable goods to be loaded on and/or unloaded from that vehicle.

 in land or premises in the said length of road or such lengths of roads accessible only therefrom.
