Proposed Traffic Calming Measures
in Meath Green Lane (D334) and Greenfields Road (D572) Horley

Surrey County Council in exercise of their powers under Section 90(A) to (I) inclusive of the Highways Act 1980 propose to introduce a series of physical measures to improve safety and reduce vehicle speeds in Meath Green Lane (D334) and Greenfields Road (D572), Horley, as follows. Road Tables in the following locations –

1. Greenfields Road, Horley, centred 10.2m north of the common property boundary of Nos. 10 and 12 Greenfields Road. The tapered edged table will measure 7.5m long by 4.6m wide, with 1.5m ramps (at 1:20 gradient).
2. Greenfields Road, Horley, centred 7.2m south-west of the Meath Green Junior School building line. The full width table will measure 7.5m long by 5.4m wide, with 1.5m ramps (at 1:20 gradient).
3. Greenfields Road, Horley, centred 14.2m north-east of the common property boundary of Nos. 1 and 3 Greenfields Road. The full width table will measure 7.5m long by 5.4m wide, with 1.5m ramps (at 1:20 gradient).
4. Meath Green Lane, Horley, centred 24.6m south of the southern kerb line of Greenfields Road. The full width table will measure 7.5m long by 5.5m wide, with 1.5m ramps (at 1:20 gradient).
5. Meath Green Lane, Horley, centred 18.5m south of the common property boundary of Nos. 45/51 and 53 Meath Green Lane. The full width table will measure 7.5m long by 5.4m wide, with 1.5m ramps (at 1:20 gradient).

All tables will rise to a height of 75mm.
