Mustard Mill Road (D6362), Staines-upon-Thames
(Prohibition of U-Turn) Order 202-

SURREY COUNTY COUNCIL propose to make under Sections 1(1) and 2(1) to (3) of the Road Traffic Regulation Act 1984, the above mentioned Order, the effect of which is that traffic proceeding in either direction on the length of road specified in the Schedule to this Notice, shall be prohibited from making a U-Turn, so as to face or proceed in the opposite direction. The above restrictions shall not apply to vehicles being used for ambulance, fire brigade or police purposes in an emergency; or in relation to anything done with the permission or at the direction of a police constable in uniform; or in accordance with any restriction or requirement indicated by traffic signs placed on the road by or on behalf of Surrey Police. A copy of the proposed Order, together with a plan showing the length of road to which the Order relates, a Statement of the Council's reasons for proposing to make the Order and a Statement of the Council's guidelines for the acceptance of objections to traffic regulation orders, may be viewed online at <https://www.surreycc.gov.uk/roads-and-transport/policies-plans-consultations/roads-and-transport-consultations> (follow the link to Mustard Mill Road prohibition of U-turn proposal). Mustard Mill Road (D6362), Staines-upon-Thames, that length which extends between the junction with the western arm (entry point) of the access road of Drive Thru Restaurant, Two Rivers Retail Park (McDonalds) and the junction with the eastern arm (exit point) of the access road of Drive Thru Restaurant, Two Rivers Retail Park (McDonalds).
