Ockley Road (A29) Beare Green and Beare Green Road/Stane Street (A29) Ockley

(40mph Speed Limit) (Revocation) Order 202-

Surrey County Council propose to make the above named Order, under Section 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 "the Act" (as amended) and all other enabling powers, the effect of which will be to —

- (a) impose a 40mph speed limit in that length of Ockley Road (A29) Beare Green and Beare Green Road/Stane Street (A29) Ockley which extends from a point 60 metres south-west of the junction with the Beare Green Roundabout south-westwards to a point 260 metres north-east of the junction with Coles Lane;
- (b) carry out legal drafting amendments to "the Surrey County Council (Horsham Road (A24) Holmwood and Bognor Road/Ockley Road (A29) Beare Green in the District of Mole Valley) (Reduction of 60 mph Speed Limit to 50 mph Speed Limit and Imposition of 50 mph Speed Limit and Revocation) Order 2012" ("the 2012 Order") so as to omit the item relating to sub-paragraph (a) above.

The speed limit proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.
