

**Surrey County Council**  
**Proposed Provision of Signal-Controlled Pedestrian Facilities**  
**(Pedex Pedestrian Crossings), and a Toucan Pedestrian/Cyclist Crossing in**  
**Old Portsmouth Road (A3100), Guildford Road (A3100)**  
**and Meadrow (A3100) Godalming**

Notice is hereby given that Surrey County Council, in exercise of their powers under Section 23 of the Road Traffic Regulation Act 1984 and Section 90(A) to (I) inclusive of the Highways Act 1980, and after consultation with the Chief Officer of Police in accordance with Section 23(2)(A) of the said Act 1984, propose to introduce - **(a)** a stand-alone signal-controlled pedestrian facility (Pedex Crossing) on Old Portsmouth Road (A3100) Godalming. The proposed crossing will be centred 22.5 metres north of the centre line of its junction with the access to the property presently known as “The Coach House” and will be 3.2 metres wide; **(b)** a stand-alone signal-controlled pedestrian facility (Pedex Crossing) on Old Portsmouth Road (A3100) Godalming. The proposed crossing will be centred 22 metres south of the centre line of its junction with (D203) Tilthams Corner Road and will be 3.2 metres wide; **(c)** a stand-alone signal-controlled pedestrian facility (Pedex Crossing) on Guildford Road (A3100) Godalming. The proposed crossing will be centred 65 metres northeast of the centre line of its junction with the access to the property presently known as “Tilthams House” and will be 3.6 metres wide; and **(d)** a Toucan Crossing on Meadrow (A3100), Godalming. The proposed crossing will be centred 33 metres southwest of the centre line of its junction with (X94052) Wyatts Close and will be 4 metres wide.
