

Surrey County Council
Proposed Traffic Calming Measures in
Catteshall Road (D5419), Wey Court (D5415),
(X94052) Wyatts Close, (X67567) Broadwater Service Road,
and the Unnamed Access leading to Broadwater Park

Notice is hereby given that Surrey County Council, in exercise of their powers under Section 90(A) to (I) inclusive of the Highways Act 1980, and after consultation with the Chief Officer of Police in accordance with Section 23(2)(A) of the said Act 1984, propose to introduce physical measures to improve safety on various roads in Godalming as follows:- **(a)** Catteshall Road (D5419) Godalming – a raised table extending for a distance of 10.5 metres south-eastwards from its junction with (A3100) Meadrow. The raised table will extend across the full width of the carriageway, and will measure 75mm in height with 1.5 metre ramps at a gradient of 1:20; **(b)** Wey Court (D5415) Godalming – a raised table extending for a distance of 6 metres north-westwards from its junction with (A3100) Meadrow. The raised table will extend across the full width of the carriageway, and will measure 65mm in height with 1 metre ramps at a gradient of 1:15; **(c)** Wyatts Close (X94052) Godalming – a raised table extending for a distance of 5 metres south-eastwards from its junction with (A3100) Meadrow. The raised table will extend across the full width of the carriageway and will measure 75mm in height with 1 metre ramps at a gradient of 1:15; **(d)** Unnamed Access leading to Broadwater Park – a raised table extending for 6.4 metres north-westwards from its junction with (A3100) Meadrow. The raised table will extend across the full width of the carriageway and will measure 75mm in height with 1.2 metre ramps at a gradient of 1:15; **(e)** (X67567) Broadwater Service Road – a raised table extending for 6.4 metres north-westwards from its southern junction with (A3100) Guildford Road. The raised table will extend across the full width of the carriageway and will measure 75mm in height with 1.2 metre ramps at a gradient of 1:15; **(f)** (X67567) Broadwater Service Road – a raised table extending for 7.1 metres north-westwards from its northern junction with (A3100) Guildford Road. The raised table will extend across the full width of the carriageway and will measure 75mm in height with 1.2 metre ramps at a gradient of 1:15.
