

**Surrey County Council**  
**Proposed Traffic Calming Measures in A287 Castle Street, A287 The Borough,**  
**A287 Downing Street and D5335 Victoria Road, Farnham**

Notice is hereby given that Surrey County Council, in exercise of their powers under Section 90(A) to (I) inclusive of the Highways Act 1980, propose to introduce a series of physical measures to improve safety and reduce vehicle speeds in Farnham, as follows: -

- 1)** A287 Castle Street, Farnham – a raised table which extends the full width of the road and is 7.5m in length, 6.4m in width and 60mm in height (flat topped) with ramp gradients of 1:20, centred at a point 110m north-west of the centreline of its junction with A287 The Borough.
- 2)** A287 Castle Street, Farnham – a raised table which extends the full width of the road and is 3.0m in length, 10.8m in width and 60mm in height (flat topped) with ramp gradients of 1:100 on the north side and 1:22 on the south side, centred at a point 2.8m north-west of the centreline of its junction with A287 The Borough.
- 3)** A287 The Borough, Farnham – a raised table which extends the full width of the road and is 7.5m in length, 3.4m - 4.3m in width and 60mm in height (flat topped) with ramp gradients of 1:25, centred at a point 100m south-west of the centreline of its junction with A287 South Street.
- 4)** A287 Downing Street, Farnham – a raised table which extends the full width of the road and is 7.6m in length, 3.6m in width and 60mm in height (flat topped) with ramp gradients of 1:25, centred at a point 76m south-east of the centreline of its junction with B3228 West Street.
- 5)** A287 Downing Street, Farnham – a raised table which extends the full width of the road and is 7.5m in length, 3.2m in width and 60mm in height (flat topped) with ramp gradients of 1:25, centred at a point 126m south-east of the centreline of its junction with B3228 West Street.
- 6)** D5335 Victoria Road, Farnham – a raised table which extends the full width of the road and is 4.0m in length, 5.0m in width and 60mm in height (flat topped) with ramp gradients of 1:25, centred at a point 149m south-west of the centreline of its junction with A287 South Street.
