Surrey County Council Reigate Road (A25) Brockham/Betchworth (40 mph Speed Limit) (Amendment) Order 202-

Surrey County Council propose to make the above named Order, under Section 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 "the Act" (as amended) and all other enabling powers, the effect of which will be to –

- (a) impose a 40mph speed limit in that length of Sevenoaks-Redhill-Guildford Road (A25) known as "Reigate Road (A25) Brockham/Betchworth" which extends from a point 25m north -east of the north-eastern kerb-line of Castle Gardens north-eastwards then eastwards to a point 47.5m west of the intersection of the centre line of Tranquil Dale with the northern channel line Reigate Road, a distance of approximately 3,220m;
- (b) carry out legal drafting amendments to "The Surrey County Council Sevenopaks-Redhill-Guildford (A25) Dorking and Coles Lane (B2126) Ockley (Revocation of 50mph Speed Limit and Imposition of 40mph Speed Limit) Order 2009" ("the 2009 Order") so as to omit the item relating to subparagraph (a) above.

The speed limit imposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.
